Dubber Selected by Telenor Sverige AB for Cloud Call Recording

- Dubber chosen as recording platform for Telenor in Sweden
- Substantial enterprise customer base with major Global Swedish Retailer as first customer
- Rollout to Telenor's 200,000 plus Unified Communications users running on BroadWorks

ASX-listed cloud call recording platform provider Dubber has been selected by Telenor as its cloud call recording platform. Telenor Sverige AB (Sweden) is part of the Telenor Group, one of Europe's largest global telecommunications providers. Telenor is a full service telecommunication provider in Scandinavia, including mobile and fixed telephony as well as providing broadband Internet access and content.

Telenor will immediately deploy Dubber's call recording platform in Sweden as part of an on-going IT and telecommunication transformation project with one of Telenor's largest clients, a global leading Swedish retailer.

Telenor's end-customer requirement to provide call recording widely to multiple disparate corporate office locations was ideally suited to Dubber's high availability and secure Cloud offering. Dubber's integration with Telenor's hosted IP telephony solution allowed Telenor to meet this customer requirement without the need for capital expenditure or a legacy hardware based approach to call recording. In turn, Telenor is able to pass on the same benefits directly to its customers by offering the latest call recording and voice data capture technology.

The agreement initially reflects at least 5,000 'Reserved' users¹ supported by the Dubber platform. A short term focus, however, is to offer both fixed and mobility based services to the Telenor Unified Communications (BroadWorks) customer base which currently exceeds 200,000.

Christian Strömlid, Head of Business Marketing, Telenor Sweden commented:

"Dubber's cloud recording platform was an ideal solution for us. The company's ability to quickly test recording on our network proved that we could meet the requirements of one of our largest corporate clients, making their selection very simple. Adopting a more traditional hardware based approach for call recording in this environment would simply not be viable for the client and would have taken months or years to implement. Using the Dubber platform in conjunction with IP telephony, has enabled us to deploy call recording to thousands of users, almost immediately.
