The aim of TikRide is to become a universal passport that will allow drivers to work across multiple organisations with minimal bureaucracy.

It is estimated that Australia has in excess of 20,000 ride-share drivers and 68,000 taxi drivers nationally<sup>1</sup>, and both AJG and TikForce are targeting to capture a significant portion of that market. As such, Australia will serve as the launching ground for TikRide, with a view to expand into international markets in 2017.

TikForce will also offer RideSafe passes as part of the TikRide offering. The RideSafe pass will give added confidence to passengers about the identity and qualifications of their driver through a simple mobile app.

Alan Butler, General Manager – International Risk, for Arthur J Gallagher (Perth) commented: “The sharing economy, including ride sharing, is gathering momentum in Australia. This is opening up new opportunities for companies to provide innovate service and technology offerings.”

“Joining forces with TikForce will bring a range of benefits to drivers who are enabled by the TikRide technology, which will also allow us to create and price insurance products in ways that were either challenging or impractical, beforehand.”

“The agreement with TikForce allows us to provide insurance at a competitive price point benefitting from the ability to reduce a number of the risks that are normally built into a standard insurance policy premium.”

TikForce’s chief executive officer, Kevin Baum, said: “Joining forces with Arthur J Gallagher is a big milestone for our Company on a few fronts.
