### One for thirty share consolidation

As previously announced, at the Extraordinary General Meeting of Shareholders on March 2 2017, the shareholders of Integrated Media Technology Limited (the “Company”) approved a consolidation of the Company’s shares. The Company is conducting the share consolidation in order to meet the Nasdaq share price listing requirement.

The Company is pleased to announce that the share consolidation will commence on the 2<sup>nd</sup> of May 2017 for the conversion of every thirty fully paid ordinary shares on issue into one fully paid ordinary share. Where the consolidation results in a shareholder having a fractional entitlement to a share, the Company will round up the entitlement to the next whole number of shares. As a result of the share consolidation, the number of shares the Company has on issue, as at the date hereof, will reduce from 79,301,852 to 2,643,611, subject to rounding, if any, on the effective date of the share consolidation.
