TikForce Enters Exclusive Agreement with AngloGold Ashanti

- TikForce enters exclusive, two-year commercial agreement with AngloGold Ashanti Australia Ltd

AngloGold Ashanti Ltd (ASX code: AGG) is a leading global gold producer, with 17 operations in 9 countries. It is listed on the JSE, NYSE and ASX.

TikForce will provide an exclusive fully managed verification and pre-qualification service of all contractors engaged on AngloGold Ashanti projects in Australia.

AngloGold Ashanti has a approximately 1,200 authorised contractors entities at its Australian operations.

Under the terms of the contract;

- AAGA shall pay Tikforce an annual subscription fee;
- AAGA's authorised users will pay transaction fees to Tikforce for the verification services; and
- Tikforce may provide consultancy services to AAGA;
