Most Significant Gas Shows to date at Dempsey

- Drilled through hard siltstone/shale section into a primary gas bearing sand
- Drilling ahead below 2,760 m (~9050 feet) to evaluate remaining conventional sandstone reservoir targets in next approximately 440 m (~1,400 feet) of drilling
- Dempsey is testing the largest undrilled structure in northeastern Sacramento Basin

Sacramento Basin-focused natural gas developer and producer, Sacgasco Limited (ASX: SGC) (“Sacgasco” or “the Company”) advises that the Dempsey 1-15 well in the Sacramento Basin in California is drilling ahead in 8 1/2” vertical hole.

After penetrating a thick section of hard shales and siltstones, drilling this morning has intersected a potential sandstone reservoir with high gas shows. These have occurred even though the drilling mud weight has been increased to control the levels of background gas for safe drilling.

Shareholders and investors are advised that the significance of these shows will become more apparent when the next wireline logs are run to more fully evaluate the intersected gas shows and reservoirs. This is planned after reaching the proposed total drilling depth of approximately 3,200 metres.

The Dempsey 1-15 well is currently drilling ahead below 2,760 m (~9,050 feet) to the highly under-explored deeper targeted reservoirs in the approximately 440 m (~1,400 feet) of remaining section to be drilled.

Dempsey is drilling the largest undrilled mapped structural closure in the northeastern part of the prolific Sacramento Gas Basin and is interpreted to be optimally located to trap gas migrating out of gas generating areas located to the west and south.

Gary Jeffery, Managing Director of Sacgasco commented:

“As previously observed it continues to be very encouraging that since drilling out of the 9 5/8” casing, all potential reservoir zones interpreted from mud logs have been associated with significant gas shows.

The latest shows are interpreted to be the most significant we have seen to date.

We continue to be very pleased with the execution of the drilling and the additional gas shows seen in the Dempsey well.

Further interpreted prospective reservoir zones remain to be drilled. Updates will be provided on meaningful results from the evaluation of the target sandstone reservoirs.”
