## SCHROLE AWARDED TENDER FOR HOSPITAL CONTRACT

Schrole Group Ltd (ASX:SCL) (**Company** or **Schrole**) is pleased to announce that since lodgement of the Company's prospectus on 18 August 2017 (**Prospectus**), the Company has been awarded the tender to implement a staff messaging system for Sir Charles Gairdner Hospital. The implementation of the system will commence shortly.

The term of the contract is for an initial one year period, with extension options at the discretion of Sir Charles Gairdner Hospital of up to a further four years. The contract value for the initial one year period is \$14,300, with a total potential contract value of up to \$55,300 over five years (assuming all extension options are exercised). Whilst the contract value is not considered by the Company to be a material amount, as set out in section 4.3(m) of the Prospectus, this contract is a positive step towards expanding the use of the Company's Schrole Cover application by providing a "white labelled" version of the software for use in other industries, such as healthcare.

**Schrole Managing Director, Rob Graham:** "The tender with Sir Charles Gairdner Hospital indicates the scope for application of our Schrole Cover system beyond schools. We are very pleased to be able to confirm we will be providing this service to hospitals, and will be actively investigating further opportunities for Schrole Cover in healthcare and other industries."
