FY18 Second Quarter Cash Flow Statement

Harris Technology Group Limited (ASX: **HT8**) today released its Appendix 4C Cash Flow Statement for the second quarter of FY18.

At the end of the Quarter the business held cash of \$1.4 million compared to \$1.1 million at September 30.

Managing Director Garrison Huang commented "The Group failed to meet revenue expectations and also experienced a slight reduction in margin. We are disappointed with our results. On reflection the looming arrival of Amazon in Australia had an impact on customer behaviour and sentiment."

"In addition, higher than expected customer rebates in the Quarter contributed to the result"

"The Groups results are traditionally stronger in the second half and recent business development initiatives indicate meaningful improvements are expected".

Information on the Groups financial results for the Half Year will be provided in February along with presentation on new initiatives.
