

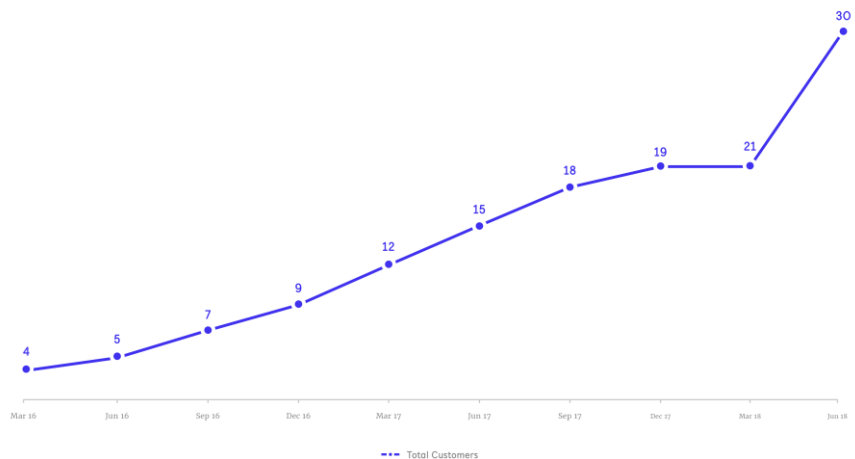
IntelliHR Holdings Limited (ASX Code: IHR) is pleased to provide the following update:
