FY18 Fourth Quarter Commentary and Cash Flow Statement

Harris Technology Group Limited (ASX: **HT8**) (the **Company**) today released its Appendix 4C Cash Flow Statement for the fourth quarter of FY18.

Managing Director Garrison Huang commented, "As foreshadowed in the Company's March Quarterly Cash Flow Statement, the Group implemented various optimisation initiatives to improve the capabilities of its sales and customer service teams, as well as a cost reduction strategy to streamline operational expenditure. The Group continued with these initiatives in the June quarter."

"The Group also implemented and successfully executed a more stringent accounts management strategy to manage its account receivables and account payables. This has resulted in a significant improvement in the Group's operating cash flow."

"In addition, the Board continues to undertake a strategic review of the Group's business portfolio, and evaluate opportunities to optimise this portfolio, through a combination of divestments of its businesses, and acquisition of complementary businesses. The Board will provide shareholders with updates once the review is complete."


