Nufarm successfully completes retail entitlement offer

- **The Retail Entitlement Offer has closed, with approximately A\$31 million in applications received**
- **Approximately 6.2 million retail entitlements will be offered under the Retail Shortfall Bookbuild, expected to commence after market close today (Monday, 22 October 2018)**

Nufarm Limited ("Nufarm") today announced the successful completion of the retail component ("Retail Entitlement Offer") of its fully underwritten 3 for 19 pro rata accelerated renounceable entitlement offer with retail rights trading ("Entitlement Offer").

Completion of the Retail Entitlement Offer represents the second stage of Nufarm's approximately A\$303 million equity raising, announced on Wednesday, 26 September 2018. The institutional component of the entitlement offer (including the institutional shortfall bookbuild) closed on Friday, 28 September 2018.

Summary of the Retail Entitlement Offer

- Approximately A\$31 million in applications under the Retail Entitlement Offer were received, representing a participation rate of approximately 46%
- Approximately 6.2 million retail entitlements will be offered under the Retail Shortfall Bookbuild (defined below), which is expected to commence after market close today (Monday, 22 October 2018)

Retail Shortfall Bookbuild

Approximately 6.2 million retail entitlements, representing entitlements not taken up by eligible retail shareholders and the entitlements of certain ineligible retail shareholders, will be offered for sale for the benefit of those shareholders in a retail shortfall bookbuild ("Retail Shortfall Bookbuild").

The Retail Shortfall Bookbuild will be conducted after market close on Monday, 22 October 2018.

The settlement date for New Shares to be issued under the Retail Entitlement Offer and the Retail Shortfall Bookbuild is expected to be Thursday, 25 October 2018. New Shares are expected to be issued on Friday, 26 October 2018 and commence trading on the ASX on Monday, 29 October 2018.
