# IOT to Act as Exclusive Advisor to develop Internet of Things opportunities in the Property Tourism Sector

The following information is provided in relation to the Consulting Agreement:

- Parties to the Agreement dated 22 September 2018 are OK IOT Group Pty Ltd (ACN: 605 630 082), a 100% owned subsidiary of IOT Group Limited (IOT), and Property Bay Holdings Pty Ltd (ACN 629 132 449) (PropertyBay).
- There are no conditions precedent.
- IOT will exclusively co-ordinate PropertyBay's Internet of Things requirements which include the following:
  - All Internet of Things devices
  - Environmental monitoring
  - Resort automation
  - Wearables
  - Energy management
  - Analytics
  - IPTV
  - IOT communication
  - IOT security
  - Brand, web and social integration
- IOT will receive a consulting fee of per \$375 per hour for an IOT Manager and \$675 per hour for an IOT Director. PropertyBay will pay all costs associated including flights, accommodation, and expenses at the end of each month.
- The Term of the Consulting Agreement is one (1) year month. PropertyBay may terminate the Agreement at any time with a 90 day's written notice and IOT can terminate with 90 days' notice.
- Mr. Neylon, executive Director of IOT, has now also joined the board of PropertyBay.
