1. ABOUT AMP CAPITAL FUNDS MANAGEMENT LIMITED

The Responsible Entity of the Fund and issuer of this PDS is AMP Capital Funds Management Limited, a member of the AMP Group, which includes AMP Capital. AMP Capital is 85% owned (indirectly) by AMP Limited. As part of the AMP Group we share a heritage that spans almost 170 years. The Responsible Entity is responsible for the overall operation of the Fund and can be contacted on 1800 759 543.

AMP Capital has been appointed by the Responsible Entity to provide investment management and associated services in respect of the Fund. This includes being responsible for selecting and managing the Fund's investments. AMP Capital has also been appointed by the Responsible Entity, under an agreement, to provide other Fund related services, including responding to investor enquiries and the preparation of this PDS on behalf of the Responsible Entity. No company in the AMP Group other than the Responsible Entity is responsible for the preparation and issue of this PDS or for any statements or representations made in this PDS.

2. HOW THE AMP CAPITAL CORPORATE **BOND FUND WORKS**

The Fund aims to deliver to its investors a regular monthly income (which exceeds the income from term deposits and government bonds) whilst seeking to provide capital stability over the medium term. The Fund primarily invests in investment-grade corporate bonds, and seeks to exploit available credit and liquidity premia as well as market inefficiencies, to deliver attractive, stable income through the cycle. We aim to preserve capital and minimise capital volatility by seeking the most attractively-priced credit securities, based on our assessment of fundamental, technical and valuation factors, as well as through implementing credit risk management strategies.

Within these markets, the Fund primarily seeks credit securities from companies exhibiting some or all of the following factors:

- capable management and good governance
- transparent financials and sustainable revenues, and
- stable to improving levels of borrowing.

Diversification is achieved mainly through investment in securities across a range of industries such as financials, utilities and telecommunication providers, with the number of securities held at any one time (typically above 100) further adding to the diversified nature of the Fund's portfolio.

Further information about the securities in which the Fund may invest is provided in the 'How we invest your money' section of this PDS.

Investing in a managed investment scheme

The Fund is a managed investment scheme structured as a unit trust and registered under the Corporations Act 2001 (Cth) (Corporations Act). A managed investment scheme is where investors' money is pooled together to purchase the Fund's assets, and it is the investment manager, not investors, who has day to day control of the Fund. The Fund's constitution, along with the Fund's PDS, the Corporations Act and other relevant laws, sets out the relationship between the Responsible Entity and investors.

The value of your investment

Investors in a Fund are issued with 'units', each of which represents a share of the value of the Fund's assets. The Fund may have a number of classes of units. Investments made through this PDS relate to mFund units. As with the other classes of units in the Fund, mFund unit prices are based on the net asset value of the Fund. This is not the same as for a listed fund, where the listed market price determines the value of the units.

Unit prices can rise and fall on a daily basis depending on a number of factors, including the market value of the Fund's assets. Consequently, the value of your investment will vary from time to

The value of your investment at any point in time is calculated by multiplying the number of units you hold, by the mFund unit price current at that time. Unit prices are updated regularly online at www.ampcapital.com and can also be obtained by contacting us.

Investing in the Fund

mFund settlement service

The Fund has been admitted to mFund, a managed fund settlement service operated by the Australian Securities Exchange (ASX). The service uses CHESS, the ASX electronic settlement system for you to apply for or redeem units in the Fund via your broker (broker-sponsored units). Your holding of the broker-sponsored units is linked to your individual Holder Identification Number (HIN), which is used to hold your other investments transacted through the ASX. If you do not currently have a HIN, you will be issued with one. The mFund settlement service does not facilitate on-market buying and selling between investors. The mFund units settled through the mFund settlement service are issued and redeemed by us.

Who can invest?

Applications to invest in the Fund through this PDS can only be made by individual and joint investors 18 years of age or over, or by partnerships, companies, trusts or superannuation funds, who receive the PDS (including electronically) within Australia. We can only accept applications submitted from within Australia. The Responsible Entity reserves the right to refuse or reject an application.

Initial investment

To invest in the Fund you will need to apply for units via your broker with your initial investment amount of at least \$10,000.

Additional and regular investments

You can make additional investments of at least \$2,000 at any time. You can also set up a regular investment plan, investing at least \$500 each month into your investment account. Monies debited from your account to pay for your regular investment plan take three (3) Business Days to clear. A Business Day for us is any day other than a Saturday. Sunday or a bank or public holiday in Sydney, NSW. For this reason, units cannot be issued until three (3) Business Days after your bank account has been debited. If the debit is unsuccessful, no units will be issued.

Initial, additional and regular investments are made on the basis of the PDS current at the time of the investment.

Accessing your money

To redeem from the Fund, you can apply to withdraw your units via your broker. A minimum withdrawal amount of \$2,000 applies, and a balance of \$10,000 is generally required to keep your investment open.

Payment times

The proceeds of your withdrawal request will usually be available within five (5) Business Days. A Business Day for us is any day other than Saturday, Sunday or a bank or public holiday in Sydney, NSW. However, under the Fund's constitution, payment and processing of withdrawal requests may take up to 30 days, or longer in some circumstances, such as if there is insufficient cash available in the Fund to meet withdrawal requests within the 30 day period.

Distributions

The Fund aims to pay income by way of monthly distributions. Income is paid based on the income earned by the Fund and the number of units you hold at the end of the income period.

You can choose to have your income payment reinvested in the Fund or paid by direct credit to your bank account by informing your broker. If no selection is made, income will be paid to your nominated account. If we do not have valid bank account details on file, your payment will be withheld until you supply valid bank account details.

You should be aware that although the Fund aims to pay income monthly, the amount of income may vary or no income may be payable in a distribution period.

3. BENEFITS OF INVESTING IN THE AMP CAPITAL CORPORATE BOND FUND

Significant features

Meeting the need for a regular income with capital stability

An important goal for many investors is being provided with a regular and reliable income stream with capital stability. This income may supplement your salary or business earnings to help build your nest egg or deliver a reliable income to help fund your lifestyle in retirement.

Investment in the Fund provides investors with access to the investment expertise demonstrated by AMP Capital's track record of managing fixed income investments.

AMP Capital and its parent company, AMP Limited, have a continuous track record of more than 40 years of fixed income investment management and is one of Asia-Pacific's largest fixed income fund managers.

4. RISKS OF MANAGED INVESTMENT SCHEMES

All investments carry risk

Assets with the highest long term returns may also carry the highest level of short term risk, particularly if you do not hold your investment for the minimum suggested investment timeframe. Additionally, different investment strategies may carry different levels of risk, depending on the assets in which a fund invests.

When you invest in a Fund, you should be aware that:

- returns are not guaranteed future returns may differ from past returns, and the level of returns may vary, and
- the value of your investment may vary, and there may be the risk of loss of invested capital.

The value of your investment may also be affected by the Fund-specific risks noted below and by other risks or external factors such as the state of the Australian and world economies, consumer confidence and changes in laws and regulations including tax laws and government policies relating to managed investment schemes.

Other factors such as your age, the length of time you intend to hold your investment, other investments you may hold, and your personal risk tolerance will affect the levels of risk for you as an investor. Risks specific to the Fund

Risks specific to the Fund may include or be associated with:

- credit the value of the Fund's investments may be sensitive to changes in the market's perception of credit quality.
- interest rates including the risk of capital loss in a rising interest rate environment.
- liquidity assets subject to liquidity risk may be difficult to trade and it may take longer for their full value to be realised, and in circumstances where the Fund's portfolio ceases to be 'liquid' for Corporations Act purposes, there may be significant delays or a freeze on withdrawal requests.
- **convertible securities** have the risk characteristics of derivatives, fixed income and share market investments, and may not be able to be readily exchanged for cash or for an equivalent asset value.
- counterparty or default risk substantial losses can be incurred if
 a counterparty fails to deliver on its contractual obligations or
 experiences financial difficulties, or if the issuers or entities upon
 which the Fund's investments depend, default on their obligations.

- derivatives the use of derivatives may magnify any losses incurred.

- investment management there is a risk that the investment manager will not perform to expectation or factors such as changes to the investment team or a change of investment manager may affect the Fund's performance.
- **listed hybrid securities** as these are a combination of debt and equity, they carry the risks associated with interest rates, derivatives and share market investments.
- securities lending although engaging in securities lending may benefit the Fund by providing increased returns, there is a risk of capital loss.
- share market investments the value of the Fund's investment in listed securities may decrease as a result of adverse share market movements.

5. HOW WE INVEST YOUR MONEY

The Fund

The Fund is a registered managed investment scheme which invests in an actively managed portfolio of credit securities, primarily investment-grade rated corporate bonds in the Australian market. The Fund also has exposure to global bond markets.

The Fund may be suitable for investors who are seeking a regular income stream with capital stability.

Asset allocation

The Fund may invest up to 100% in investment grade rated corporate bonds, and may hold up to 10% in non investment grade rated securities and up to 15% in unrated corporate bonds.

Investment return objective

The Fund aims to deliver regular monthly income and capital stability to investors over the medium term, and to provide total returns (primarily income with some capital growth) above the Fund's benchmark over a rolling 3 year basis.

6. FEES AND COSTS

DID YOU KNOW?

Small differences in both investment performance and fees and costs can have a substantial impact on your long term returns. For example, total annual fees and costs of 2% of your investment balance rather than 1% could reduce your final return by up to 20% over a 30 year period (for example, reduce it from \$100,000 to \$80,000).

You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs. You may be able to negotiate to pay lower contribution fees and management costs where applicable. Ask the fund or your financial adviser.

Management costs are expressed as a percentage of the Fund's net assets. Management costs are made up of a management fee of 0.60%pa, recoverable expenses of 0.00% pa and estimated other indirect costs of 0.00% pa. The sum of these figures may differ to the total management costs, due to rounding. The recoverable expenses are the expenses reimbursed from the Fund in the previous financial year. Recoverable expenses are likely to be reimbursed from the Fund in future years. Refer to the 'Additional explanation of fees and costs' in the 'Incorporated information' for further details.

Changes to fees

The Responsible Entity may change the fees noted in this PDS at its discretion and without the consent of investors. For example, fees may be increased where increased charges are incurred due to changes to legislation, where increased costs are incurred, if there are significant changes to economic conditions, or if third parties impose or increase processing charges. However, we will give investors 30 days' written notice of any intention of the Responsible Entity to increase the existing fees or introduce performance fees or contribution or withdrawal fees.

7. HOW MANAGED INVESTMENT SCHEMES ARE TAXED

8. HOW TO APPLY

Investing in the Fund

You will need to apply via your broker using the ASX settlement system for broker-sponsored units when you apply for an initial investment in the Fund, make an additional investment, or set up a regular investment plan. Your holding of the broker-sponsored units will be linked to your individual HIN that is used to hold your other investments transacted through the ASX. If you do not currently have a HIN, you will be issued with one.

The offer to invest in the Fund is subject to the terms and conditions described in the PDS and the incorporated information current at the time of contributing your investment amount. You can obtain these documents, free of charge, at **www.ampcapital.com/mfund** or by contacting us on 1800 759 543.

We generally process applications and withdrawal requests each Business Day, using the close of business issue price for that day. A Business Day for us is any day other than Saturday, Sunday, or a bank or public holiday in Sydney, NSW. The cut-off time for mFund units is 11.15am. Any applications or withdrawal requests we receive after the cut-off time will be processed effective the next Business Day.

Cooling off rights

Where your application to invest or reinvest in the Fund has been accepted, you can request the return of your initial investment within a 14 day cooling-off period. The 14 day cooling-off period commences on the earlier of the fifth Business Day after we issue the units to you or from the date you receive confirmation of your transaction.

The amount returned to you may be less than the amount of your initial investment in the Fund due to adjustments to take into account such factors as changes in the unit price or any tax payable on the units. Your investment cannot be returned if you have exercised any rights or powers available under it.

Complaints procedure

AMP Capital and the Responsible Entity follow an established procedure to deal with complaints. We are committed to providing you with a high level of service, but sometimes things go wrong. If this happens, we will help you resolve the issue.
