The Company has today issued 261,550,000 new shares following receipt of applications totalling \$523,100. The SPP provided registered shareholders as at 4:00pm (WST) on 30th January 2019 the opportunity to subscribe for up to \$15,000 worth of shares at an offer price of \$0.002 per share without having to pay brokerage or other transaction costs.

The funds raised will be used to bolster the Company's general working capital position, maintain a strong net cash position and to fund exploration, including drilling on its Argentina projects.
