Notice under Section 708A(5)(e) of the Corporations Act

On 14 June, 2019 Altech Chemicals Limited (**Company**) issued 18,433,180 fully paid ordinary shares (**Shares**) to SMS Investments SA at \$0.1085 per share for total consideration of \$2.0 million, as approved by shareholders in General Meeting on 6 June 2019. The issue of the shares falls within one of the exemptions set out in section 708 of the Corporations Act.

The Company gives this notice pursuant to Section 708A(5)(e) of the Corporations Act.

The shares were issued without disclosure to investors under Part 6D.2, in reliance on Section 708A(5) of the Corporations Act.
