

NetComm Shareholders vote in favour of Scheme of Arrangement

Tuesday 18 June 2019 (Sydney)

NetComm Wireless Limited (ASX: NTC) is pleased to announce that at its shareholder meeting held in Sydney earlier today, the Scheme of Arrangement (**Scheme**) pursuant to which NetComm will be acquired by Casa Systems, Inc. (Nasdaq: CASA) was approved.

The resolution to approve the Scheme, as set out in the Notice of Meeting attached to the Scheme Booklet dated 1 May 2019, was passed by the requisite majorities of NetCom Shareholders.

The final results of the poll were as follows:

The Scheme remains subject to Court approval at a hearing which has been set for 2.15 pm on Thursday, 20 June 2019.

Scheme Consideration

If the Scheme is approved by the Court, NetComm shareholders will be entitled to receive \$1.10 cash for each NetComm share held on the Scheme Record Date, in accordance with the Scheme.
