**Sydney, Australia – 21 June 2019:** Cannabis focused healthcare company, Bod Australia Limited (“Bod”, the “Company”) (ASX: BDA) has secured a distribution agreement with Burleigh Heads Cannabis (BHC) and partner company, Cannabis Doctors Australia (CDA) for its pharmaceutical grade medicinal cannabis product, MediCabilis™ 5% CBD ECs315 (MediCabilis™).

BHC is a leading Australian distributor and supplier of medicinal cannabis products. BHC is dedicated to providing premium natural cannabinoid medicines for the benefit of the community.

Under the agreement, Bod will gain access to BHC’s wholesale network and partner company, Cannabis Doctors Australia. CDA provides education, support and products to patients and doctors seeking access to medicinal cannabis in Australia.

CDA a number of clinics and an established patient base throughout Australia. Since October 2018, CDA have successfully processed over 1,300 Special Access Scheme Category B approvals, resulting in more than 1,800 medicinal cannabis prescriptions. The Group is also expanding into New Zealand in the near term.

CDA has commenced patient approvals for MediCabilis™ through its physical clinics and telehealth service. Bod anticipates strong demand from patients with prescriptions to increase over the coming months. These sales will have the potential to underpin revenue growth for Bod Australia.

The consistency, premium quality, reliability and safety data associated with MediCabilis™ were instrumental in securing the agreement. Bod is now well placed to meet the growing demands of patients that are seeking premium quality, safe and consistent medicinal cannabis products.

Bod will also access CDA’s extensive network of medical specialists and physicians through its Medicinal Cannabis Education Program, which gives patients greater access to Bod’s superior range of clinically trialled products.

Further, Bod and BHC intend to collaborate to produce novel non-THC cannabis prescription products to meet growing physician and patient needs.

**Bod Australia CEO Jo Patterson said:** "Burleigh Heads Cannabis and Cannabis Doctors Australia are leaders in medicinal cannabis and have extensive networks of medical specialists, physicians and patients nationwide. This provides an excellent foundation for Bod to grow medicinal cannabis sales much more rapidly in Australia and New Zealand in the coming months.

"As well, Bod is in ongoing discussions with a number of potential distribution partners internationally to drive further revenue growth and looks forward to updating shareholders in the near term."
