## DULUXGROUP SHAREHOLDERS APPROVE SCHEME

DuluxGroup Limited (**DuluxGroup**) announces that DuluxGroup shareholders have approved the scheme of arrangement (**Scheme**) between DuluxGroup and its shareholders pursuant to which Nippon Paint Holdings Co., Ltd. will acquire all issued shares in DuluxGroup.

### Results of the Scheme Meeting

The resolution to approve the Scheme was approved by the requisite majorities of DuluxGroup shareholders at today's Scheme Meeting. The voting results of the Scheme Meeting are **attached**.

### Next steps

DuluxGroup has applied to the Federal Court of Australia (**Court**) for approval of the Scheme at a hearing scheduled for 6 August 2019.

If the Scheme is approved by the Court, DuluxGroup shareholders on the share register on the Scheme Record Date will be paid the Scheme Consideration of \$9.37 per DuluxGroup share. Payment is expected to be made on 21 August 2019.
