## FINEOS Corporation Holdings plc (ASX: FCL) – Admission and Commencement of Official Quotation – Deferred Settlement Trading

### Description

FINEOS Corporation Holdings plc ('FCL') is expected to be admitted to the Official List of ASX Limited ('ASX') on Friday, 16 August 2019.

Official quotation of FCL's CHESS Depository Interests ('CDIs') is expected to commence at 1:00PM AEST on Friday, 16 August 2019 on a **deferred settlement basis**.

Each CDI represents fully paid ordinary shares in FCL at a ratio of 1 for 1.

FCL raised approximately \$211.0 million pursuant to the offer under its prospectus dated 26 July 2019 ('Prospectus') by the issue and transfer of 84,389,893 CDIs at an issue and sale price of \$2.50 per CDI.
