TRANSCENDENCE TECHNOLOGIES LIMITED SEPTEMBER 2019 QUARTERLY ACTIVITIES REPORT

The Board of Transcendence Technologies Limited (**TTL** or the **Company**) provides the following report on its activities and operations for the quarter ended 30 September 2019.

On 23 September 2019, the Company was suspended from official quotation in accordance with Listing Rule 17.3, as ASX determined that TTL's operations are not adequate to warrant the continued quotation of its securities pursuant to ASX Listing Rule 12.1. The suspension will continue until the Company is able to demonstrate compliance with Listing Rule 12.1.

The Company is continuing to review complementary acquisition and investment opportunities, to determine if any of them have a strategic or commercial fit.

During the quarter, a total of 73,554,272 quoted options exercisable at \$0.05 each on or before 11 August 2019 (TTLO Options) expired unexercised.

At the end of the quarter, the Company had cash reserves of approximately \$1.048 million. The Appendix 4C report attached to this report contains the Company's cash flow statement for the quarter.
