SHARE PLACEMENT CLEANSING NOTICE and APPENDIX 3B**

Byron Energy Limited (**Byron** or **the Company**) (**ASX:BYE**) is pleased to announce the completion of the share placement to institutional and professional investors (**Placement**) announced to the market on 15 November 2019, raising approximately \$A14.0 million, before costs, through the issue of 51,961,055 shares (**Placement Shares**).

Byron gives notice under section 708A(5)(e) of the *Corporation Act 2001* (Cth) (**Corporations Act**). The Placement Shares issued under the Placement were issued without disclosure to investors under Part 6D.2 of the Corporations Act.

Byron makes the following statements for the purposes of compliance with section 708A(6) of the Corporations Act:

- a) as at the date of this notice, Byron has complied with the provisions of Chapter 2M (as they may apply to Byron) and section 674 of the Corporations Act; and
- b) as at the date of this notice, there is no information that is “excluded information” (as defined in sections 708A(7) and 708A(8) of the Corporations Act).
