



Completion of Placement

Issue and Allotment of 27,435,789 Shares

On 27 November 2019, Helios Energy Ltd (ASX Codes: HE8, HE8OA) (**Helios** or **Company** or **Issuer**) advised that it has conducted a capital raising of \$5,212,800 by way of the issue of 27,435,789 shares at a price of 19 cents per share (**Placement**). The Placement was made to sophisticated and professional investors under the provisions of section 708 of the Corporations Act 2001 (Cth). The Placement was conducted within the 15% placement capacity available to the Company in accordance with ASX Listing Rule 7.1.

The Company has completed the issue and allotment of 27,435,789 shares of the Placement at 19 cents per share to raise \$5,212,800.
