### 6.1 Further information relating to the consolidation or split

As the milestones of the 100,000,000 Class A Performance Shares and 50,000,000 Class B Performance Shares were not satisfied, the Performance Shares will be cancelled prior to the Consolidation on 15 March 2020, being the date 4 years from being readmitted to quotation, in accordance with the terms of the Performance Shares.

100,000,000 Class A Performance Rights and 100,000,000 Class B Performance Rights (CIOAD) will be consolidated into 10,000,000 Class A Performance Rights and 10,000,000 Class B Performance Rights as set out in the Company's Notice of Meeting.
