Completion of January 2020 Equity Raising Final issue of Tranche 2 Placement Shares

Resolute Mining Limited (ASX/LSE: RSG, Resolute or the Company) is pleased to advise the successful completion of Tranche 2 of the Company's ~A\$195 million Equity Raising launched in January 2020 (see ASX Announcement dated 21 January 2020). To complete Tranche 2, the Company has today issued 7,743,797 shares to ICM Limited nominees (ICM) at a price of A\$1.10 per share.

The Equity Raising comprised a two-tranche placement and share purchase plan (SPP) both of which received strong support from new and existing shareholders. The Tranche 1 Institutional Placement shares and the SPP shares were issued on 30 January 2020 and 3 March 2020 respectively. The Tranche 2 placement shares were approved by the Company's shareholders at an Extraordinary General Meeting (EGM) held in February 2020 (see ASX Announcements dated 27 February 2020). The EGM approved the issue of a total of 22,727,273 Tranche 2 shares at a price of A\$1.10 per share which included the purchase of shares by ICM and Resolute's Managing Director & CEO, Mr John Welborn, Resolute's Non-Executive Chairman, Mr Martin Botha, and Resolute Non-Executive Directors Ms Yasmin Broughton and Ms Sabina Shugg.

In April 2020, 14,983,476 Tranche 2 placement shares were issued to ICM and Resolute Directors (see ASX Announcements dated 8 April 2020). Today's final issue of a further 7,743,797 shares to ICM completes the Tranche 2 placement and finalises the ~A\$195 million Equity Raising.
