### **CARBON REVOLUTION MARKET UPDATE – COVID-19**

Geelong, Australia, 28 May 2020: Geelong-based advanced manufacturer Carbon Revolution Limited (ASX:CBR), whose lightweight carbon fibre wheels are used on some of the world's premier cars, is pleased to provide a market update.

Further to our previous update on the 24 of April 2020, as Europe and the USA are relaxing their Covid-19 restrictions, the business' key customers are returning to production:

- Ferrari restarted production early May with a return to full production on the 8<sup>th</sup> of May
- Ford Flat Rock assembly plant (which produces the Mustang GT500) resumed production this week on one shift and Ford have stated "the ramp-up process will be gradual as workers adjust to the new health and safety protocols and the entire supply chain comes up to speed"

During their lockdowns, all customers requested that Carbon Revolution maintain production as they expect resumption of production of relevant car models post lockdown.

The Carbon Revolution team has remained healthy and focused whilst embracing the Covid-19 related work practices and restrictions. Some of our imposed restrictions will be gradually lifted in line with government guidelines.

The business remains well capitalised and ready to continue its growth plans as markets regain momentum.
