**Request of Trading Halt**

Pursuant to ASX Listing Rule 17.1 Ausmex Mining Group Ltd (ASX:AMG) (the “**Company**”) and at the request of the ASX, the Company hereby requests that a voluntary trading halt of the Company’s securities be granted by the Australian Securities Exchange.
