NEW AUGER LABORATORY RESULTS CONFIRM EXTENSIVE HIGH GRADE HEAVY MINERAL SAND MINERALISATION AT POIOMBO, CORRIDOR SOUTH PROJECT, MOZAMBIQUE

Key Highlights:

- NEW HAND AUGER LABORATORY RESULTS TO 12 METRES FROM SURFACE CONFIRM PREVIOUS VISUAL ESTIMATES OF HIGH GRADE HMS MINERALISATION AT POIOMBO.
- RESULTS INDICATE THE POIOMBO TARGET FOOTPRINT IS UP TO 5KM EAST-WEST AND AT LEAST 2.5KM WIDE IN THE CENTRAL PORTION, REPRESENTING A MINERALISED FOOTPRINT OF >12 SQ KM. COMBINED WITH VISUAL AIRCORE DRILLING RESULTS (REFER FIGURE 2, ASX ANNOUNCEMENT 25 MARCH 2020), VERY HIGH GRADE ZONES WEST AND EAST OF POIOMBO TOWNSHIP ARE EVIDENT.
- 12 OF 31 AUGER HOLES ASSAYED COMPRISED AVERAGE DOWNHOLE GRADE >4% THM AND 6 HOLES ENDED WITH FINAL SAMPLE INTERVAL >5% THM.
- SIGNIFICANT RESULTS IN THE POIOMBO AUGER ASSAY DATA INCLUDE:
 - 12M @ 5.48% THM (HOLE 20CSHA254) FROM SURFACE & ENDED IN 5.82% THM.
 - 12M @ 5.34% THM (HOLE 20CSHA259) FROM SURFACE & ENDED IN 5.09% THM.

Background

MRG Metals Ltd (MRG) (ASX Code:MRQ) is pleased to provide significant laboratory assay results from auger drilling on the Poiombo target within the Corridor South tenement (6621L). This new auger data set for Poiombo confirms the auger visual estimate data (refer ASX announcement 4 March 2020) and aircore visual estimate data (refer ASX announcement 25 March 2020) and further underpins the significant potential for definition of a new high grade heavy mineral sand (HMS) resource at Poiombo.




Figure 1: Location map of hand auger holes in the Poiombo target area showing new summary laboratory data (white halo) for THM grades. Certain hole numbers are shortened (e.g. HA237) for presentation but are prefixed by '20CS' in Table 1.

The laboratory results are for a series of 201 primary samples from a total of 31 auger holes, comprising 301.5m of drilling. The hole numbers include 20CSHA224-235 and 20CSHA237-254 and 20CSHA259 (Figure 1).

Overall, the laboratory results show 12 of the holes attained an uncut average downhole grade >4% THM, with 3 of the 12 holes having an uncut average downhole grade of >5% THM. There are 6 holes that end in \geq 5% THM and there are 5 holes that were collared at surface with grade \geq 5% THM. Also, from previous auger drilling, there is 9.0M @ 6.63% THM (HOLE 19CSHA056) from surface which ended in 7.13% THM (refer ASX announcement 9 October 2019).

These laboratory results confirm there is a new high grade HMS target emerging at Poiombo that remains open to the northwest and southeast. The visual estimated THM% grades reported previously (refer ASX announcement 4 March 2020) noted the footprint of the HMS mineralisation is about 4km x 3km in the central portion east of the main road. However, the new laboratory results confirms the mineralised footprint extends to the west side of the main road and is up to 5km east-west (at \geq 3.5% THM).

The early potential of Poiombo to host a high grade HMS deposit was established in October 2019 (refer ASX Announcement 9 October 2019) from reconnaissance auger hole 19CSHA056, located in the heart of the mineralized zone reported here. 19CSHA056 was collared at surface in 5.95% THM (0-1.5m) and ended in 7.13% THM (7.5-9.0m) with a maximum of 7.26% THM. Overall, 19CSHA056 delivered a downhole average of 6.63% THM. Slime values related to hole 19CSHA056 are moderate, with a range of 8.35%-17.40% and an average of 14.85%.

MRG Chairman, Mr Andrew Van Der Zwan, said "The substantive assay results at Poiombo combined with initial aircore drilling results confirm the potential for a very large high grade resource from surface and in some areas continuing to depth. We are on the verge of another discovery, evidenced by the very high grades intersected in strandline zones at surface and near surface. This is exactly what we are are looking for with our targeted programs, which we believe will provide multiple infill aircore programs for later in the year. The program to date at Poiombo looks to have identified the potential for significant tonnage at very significant grades. Mozambique continues to operate in a COVID-19 Pandemic restricted environment. However, we have been able to maintain in country operations and will continue to do so safely until instructed otherwise."

Auger Sample Laboratory Results

The auger drilling reported here was part of a program of broad-spaced holes at 500m stations on traverses 1000m apart and designed to test magnetic geophysical anomalies.

The best hole returned within this new laboratory batch is 20CSHA254, which was located south-central part of the target, outside of the interpreted magnetic anomaly, and returned 12m @ 5.48% THM (from surface). This hole ended in 5.82% THM (10.5m-12.0m) and contained a maximum individual grade of 5.91% THM from 9.0-10.5m (Table 1; Figure 1). Slime values related to hole 20CSHA254 are moderate, with a range of 6.85%-14.96% and a reasonably low average of 12.44%.

Also, significant in the new data is hole 20CSHA259, which comprises an uncut downhole average of 5.34% THM, from 0.0-12.0m (Table 1, Figure 1). Hole 20CSHA259 is located on the northeast side of the magnetic anomaly and has a peak grade of 6.26% THM in the sample interval 9.0-10.5m. This hole ended in 5.09% THM in the interval 10.5-12.0m.

The Oversize fraction characteristics of the auger sample series reported here show a range from 0.12% to 5.00%, with an average of 0.83%.

Additional auger drilling is planned to further define the Poiombo target mineralised footprint, particulary on the southeast side.

Heavy mineral concentrates from the holes presented here are being selected for preparation of composite samples to submit for mineral assemblage characterisation analysis.

Aircore drill samples from the Poiombo program undertaken in March 2020 are now at Western GeoLabs for analysis and results are expected by mid June 2020 and will be reported as soon as possible after receipt. Also, auger samples from the Nhacutse target have arrived in Perth and are now being quarantine treated prior to delivery at Western GeoLabs on about 12 June 2020.

Auger Drilling Details

Auger holes were selected for laboratory analysis by filtering average downhole visual estimated THM%, with only samples from those holes attaining ≥3% average visual THM being selected for laboratory analysis.

Auger samples were sent to Western GeoLabs in Perth for heavy liquid separation analysis. Samples were initially oven dried and disaggregated if required by hand, weighed and then split to approximately 100g sub-samples. The sub-sample was wetted and attritioned to ensure further breakdown of any clay aggregates and then de-slimed at 45μ m to measure Slime percent. The sub-sample was then screened at +1mm to remove and measure Oversize percent. The $+45\mu$ m-1mm fraction was then subjected to heavy liquid separation (HLS) with tetrabromoethane (TBE) at specific gravity of 2.95. The settling time for HLS was 45 minutes with several stirs of the liquid to ensure adequate heavy mineral 'drop'.

In terms of QAQC, field duplicate samples are prepared at a frequency of 1 per 25 primary samples and submitted 'blind' to the laboratory. A Standard Reference Material (SRM) sample was inserted into the field sample batch at a frequency of 1 per 50 primary samples. At the laboratory, additional duplicates are routinely prepared at a frequency of 1 per 10 primary samples.




Figure 2: Location map of the Poiombo target (Corridor South project 6621L) aircore drillholes completed in March 2020, showing summary visual estimated data for THM grades.

Aircore Laboratory Assay Results to Follow

Laboratory assay results from a 10 hole reconnaisance aircore drilling program completed in March 2020 at Poiombo are due next week. This aircore drilling intersected strandline style HMS mineralization in holes drilled within the mineralized footprint.

Visually estimated grade from these holes included: 51m @ 6.1% THM, 36metres @ 5.5%THM and 36metres @ 5.4% THM; with individual 3 metre intervals delivering visually estimated grade up to 19% THM (refer ASX announcement 25 March 2020).
