Between Jan 2019 and September 2019, 4 loan facilities agreement was signed between the Company and the newly appointed Managing Director, Senlin Liu, who provided a secured loan of total up to A\$1,800,000 of 12%, an unsecured loan of total up to RMB20,000 and an unsecured loan of total up to A\$41,808.12 of 12%.

A loan agreement was signed between the Company and Asia New Energy who provided a secured loan of total up to USD764,840 of 12%.

A loan agreement was signed between the Company and the newly appointed Managing Director, Madam Freada Cheung who provided a secured loan of total up to HKD400,000 of 12%.

Answer: No, the Company significantly its costs as it was no longer required to pay any cash to staff. Thus, the cashflow for the following quarter was approximately negative \$30,000. The Company was in negotiations to raise further funds.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The Company issued further convertible notes in late December 2019 and in February 2020. They were approved at the Company's AGM held on 18 May 2020. The Company continues to explore fundraising opportunities.
