# BLACKSTONE INTERSECTS 200M LONG HIGH-GRADE NICKEL-COPPER-PGE ZONE AT BAN CHANG

Blackstone's maiden drill hole BC20-02 at Ban Chang has delineated a 200m long zone of high-grade Nickel-Copper-PGE with the following high-grade results:

BC20-02 4.1m @ 0.92% Ni, 0.69% Cu, 0.05% Co & 0.26g/t PGE <sup>1</sup> from 85.9m

or **2.3m @ 1.6% Ni, 1.09% Cu, 0.09% Co & 0.43g/t PGE** from 85.9m


Incl. **1.8m @ 2.01% Ni, 1.27% Cu, 0.12% Co & 0.53g/t PGE** from 86.4m




Figure 1: Ban Chang prospect with 1.2km long of EM plates and drill holes BC20-01, BC20-02, BC20-03 & BC20-04

- Blackstone's four maiden drill holes at Ban Chang have all intersected massive sulfide nickel over a 1.2km strike within a 1.2km long massive sulfide target zone defined by high priority electromagnetic (EM) plates (refer to Figure 1);
- Assays are pending for drill hole BC20-04 (ASX announcement 11 June 2020), which intersected **15.4m of sulfide vein mineralisation**;
- Blackstone is targeting massive sulfide vein (MSV) prospects analogous to the Ban Phuc MSV, where previous owners successfully mined 975kt of high-grade ore at average grades of 2.4% Ni & 1.0% Cu from an average vein width of 1.3m for 3.5 years between 2013 and 2016, producing 20.7kt Ni, 10.1kt Cu and 0.67kt Co;
- A recently purchased third drill rig will follow the geophysics crew throughout the Ta Khoa nickel sulfide district, testing high priority EM targets generated from 25 MSV prospects including King Snake, Ban Khoa, Ban Chang, and Ta Cuong (refer to Figure 4);
- Drilling continues with Blackstone's largest drill rig testing the King Cobra Discovery zone (KCZ) and Blackstone's two smaller drill rigs at Ban Chang East and Ban Chang West;
- With its third diamond drill rig, the Company has an "all-in" diamond drilling cost of US\$50/m at Ta Khoa, a ~60% reduction in drilling costs relative to Australian industry averages²;

 Blackstone's Scoping Study on downstream processing to produce nickel sulfate for the lithiumion battery industry and Ban Phuc maiden resource are on track for completion in Q3, CY20;



Blackstone Minerals' Managing Director Scott Williamson commented:

"Our latest assays confirm further high-grade mineralisation at Ban Chang. We continue to demonstrate strong potential for a bulk underground mining scenario at Ban Chang which could be significantly larger scale than the previously mined Ban Phuc massive sulfide underground mine. At Ban Phuc, the previous owners successfully mined a 1.3m wide MSV at much lower nickel prices than today. We are seeing broader widths and significant by-products which could lend to potentially better economics than when this mine previously operated.

"We have now drilled significant massive sulfide nickel mineralisation over 1.2km of strike at Ban Chang and our in-house geophysics crew continues to test for further massive sulfide mineralisation at the new target, Ta Cuong.

"Ban Chang and Ta Cuong are the first of our 25 MSV targets to be tested throughout the Ta Khoa Ni-Cu-PGE district, leaving plenty of upside for adding high-grade feed to what looks like a bulk open pit mining scenario at Ban Phuc and the KCZ."

Blackstone Minerals Limited (ASX code: BSX) is pleased to announce it has intersected massive sulfide in four maiden drill holes at Ban Chang, part of its Ta Khoa Nickel-Cu-PGE project in Vietnam (refer to Figure 5). The drill holes were drilled more than 1.2km apart and along strike within a 1.2km-long massive sulfide target zone defined by high priority EM plates.




Figure 2: Ban Chang Cross Section 52225E showing maiden drill hole BC20-01 (refer to ASX announcement 17 June 2020)

Blackstone's previously announced maiden drill hole BC20-01 intersected the following high-grade results (refer to Figure 2):

BC20-01 5.2m @ 0.66% Ni, 0.73% Cu, 0.04% Co & 0.79g/t PGE from 58.0m

or **1.5m @ 2.20% Ni, 2.12% Cu, 0.13% Co & 2.66g/t PGE** from 58.5m

Incl. **1.05m @ 2.98% Ni, 1.22% Cu, 0.18% Co & 3.43g/t PGE** from 58.5m




Figure 3: Ban Chang Cross Section 52450E showing maiden drill hole BC20-02 (refer to tables 1&2)

Blackstone is pleased to announce maiden drill hole BC20-02 at Ban Chang which is located 200m along strike of maiden drill hole BC20-01 has intersected the following high-grade results (refer to Figure 3):

BC20-02 4.1m @ 0.92% Ni, 0.69% Cu, 0.05% Co & 0.26g/t PGE from 85.9m

or **2.3m @ 1.6% Ni, 1.09% Cu, 0.09% Co & 0.43g/t PGE** from 85.9m

Incl. **1.8m @ 2.01% Ni, 1.27% Cu, 0.12% Co & 0.53g/t PGE** from 86.4m

Blackstone's drill hole BC20-03, located more than 1km along strike from Blackstone's maiden drill hole BC20-01 at Ban Chang (ASX announcement 17 June 2020) (refer to Figure 1), delivered the high-grade result of:

BC20-03 9.8m @ 1.45% Ni, 0.9% Cu, 0.08% Co & 0.70g/t PGE from 57.05m

or 5.7m @ 2.07% Ni, 1.08% Cu, 0.12% Co & 0.95g/t PGE from 60.0m

Incl. **1.85m @ 3.59% Ni, 1.18% Cu, 0.20% Co & 1.97g/t PGE** from 63.35m

Hole BC20-04 intersected a 15.4m wide zone of sulfide vein mineralisation (*refer to Figure 1*). The drilling is part of an ongoing campaign to target regional MSV as Blackstone aims to build its resource inventory at Ta Khoa to supplement the Ban Phuc maiden resource, which is on track for completion in Q3, 2020.



## **Ban Chang**

The Ban Chang prospect is located 2.5km south-east of the processing facility and the Ban Phuc deposit adjacent to the Chim Van – Co Muong fault system. The prospect geology consists of a tremolitic dyke swarm within phyllites, sericite schists and quartzites of the Devonian Ban Cai Formation. The known mineralization style is mainly veins and lenses of massive sulfide as well as disseminated sulfide (DSS) hosted within tremolite dykes. The dyke swarm is approximately 900m long and varies between 5m and 60m wide. The dykes and massive sulfide are interpreted to be hosted within a splay (and subsidiary structures) off the major regional Chim Van – Co Muong fault system.

The West Zone is a 420m long zone of interpreted bifurcating MSV lenses. This zone strikes NW-SE and dips moderately to the SW. The Central Zone is consistent in strike and dip with the West Zone, defined by a weathered gossan which is 200m long and up to 1.4m wide and containing 0.18- 0.27% Ni and 1.29-1.38% Cu. The prospect area was historically mapped and trench sampled (19 trenches) by Vietnamese geologists in the 1960-63 period. The largest intersection obtained in this period was in Adit Level 13 which intersected patchy zones of weak nickel-copper mineralisation. Channel samples included 3.9m at 1.07% Ni & 0.95% Cu including 1.1m at 1.62% Ni & 1.48% Cu. Drill hole BLK 4 intersected a zone of 1.7m at 1.89% Ni & 0.91% Cu from 62.9m. Drill hole BLK 2 intersected a 1m wide MSV within schist grading 2.65% Ni & 1.07% Cu from 58.5m down hole.




Figure 4: Ta Khoa Nickel-PGE (Cu-Co) district



## Ta Khoa Nickel-Copper-PGE Project - Next Steps



Blackstone Minerals aims to deliver a maiden resource in Q3, focused initially on the DSS at Ban Phuc and continues to investigate the potential to restart the existing Ban Phuc concentrator through focused exploration on both MSV and DSS deposits.

Blackstone Minerals has commenced a scoping study on the downstream processing facility at Ta Khoa. The scoping study, also to be announced in Q3, will provide details for joint venture partners to formalise the next stage of investment. Blackstone Minerals has commenced metallurgical testing on the Ban Phuc DSS deposit with an aim to develop a flow sheet for a product suitable for the lithium-ion battery industry.

In addition, Blackstone Minerals will investigate the potential to develop downstream processing infrastructure in Vietnam to produce a downstream nickel and cobalt product to supply Asia's growing lithium-ion battery industry.

The Ta Khoa Nickel-Copper-PGE Project in northern Vietnam includes an existing modern nickel mine which has been under care and maintenance since 2016 due to falling nickel prices. Existing infrastructure includes an internationally designed 450ktpa processing plant. Previous project owners focused mining and exploration efforts primarily on the MSV at Ban Phuc.

Blackstone Minerals plans to explore both MSV and DSS targets throughout the project, initially within a 5km radius of the existing processing facility. Blackstone Minerals will conduct further geophysics on the MSV and DSS targets and continue its maiden drilling campaign.
