
On 17 August 2020, ARA BidCo lodged a replacement bidder's statement in relation to a proportional off-market takeover offer to acquire 29% of the stapled securities not currently owned by the ARA Group in Cromwell Property Group, comprising Cromwell Corporation Limited and Cromwell Diversified Property Trust, for which the responsible entity is Cromwell Property Securities Limited (together, **Cromwell**).
