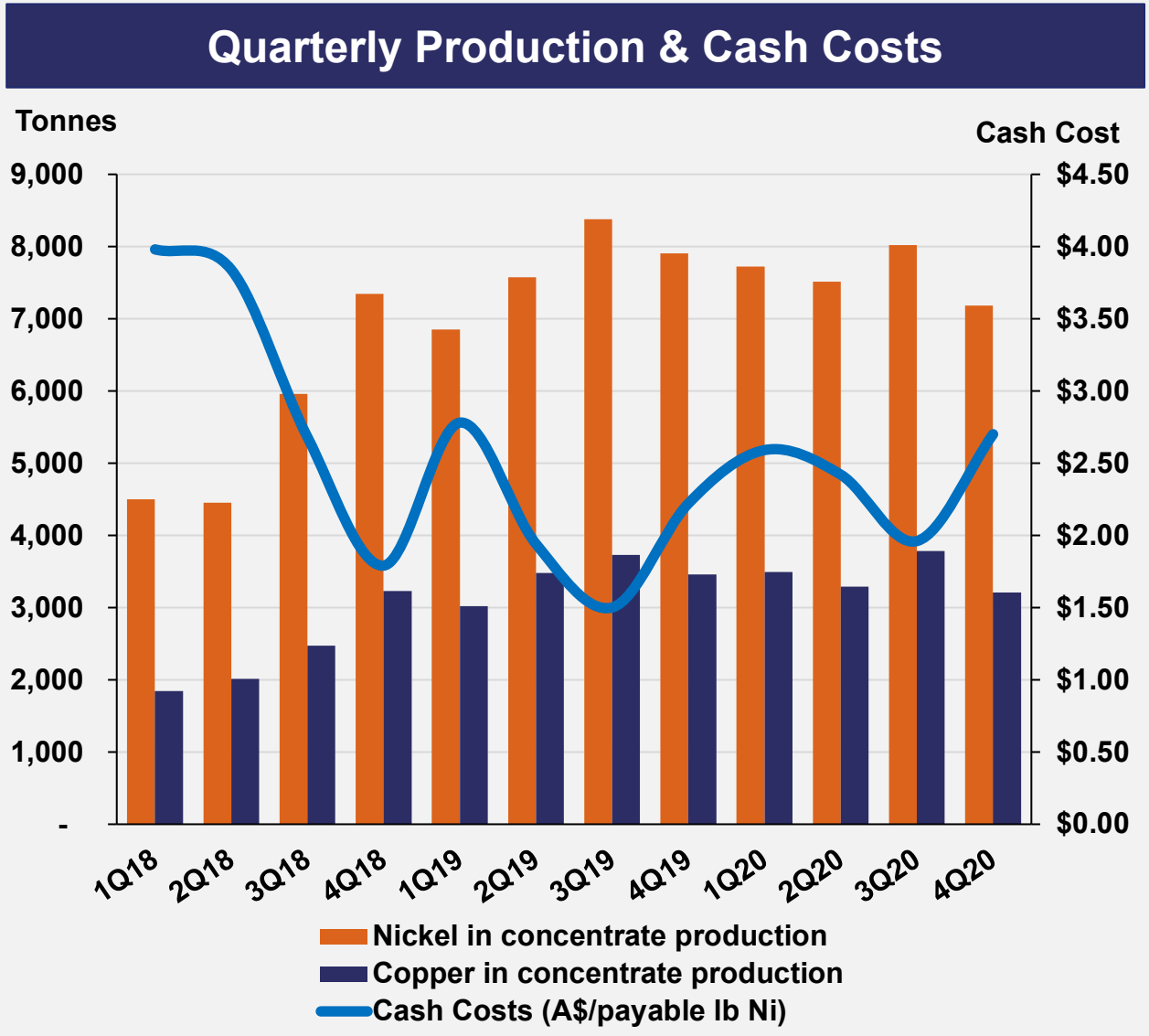

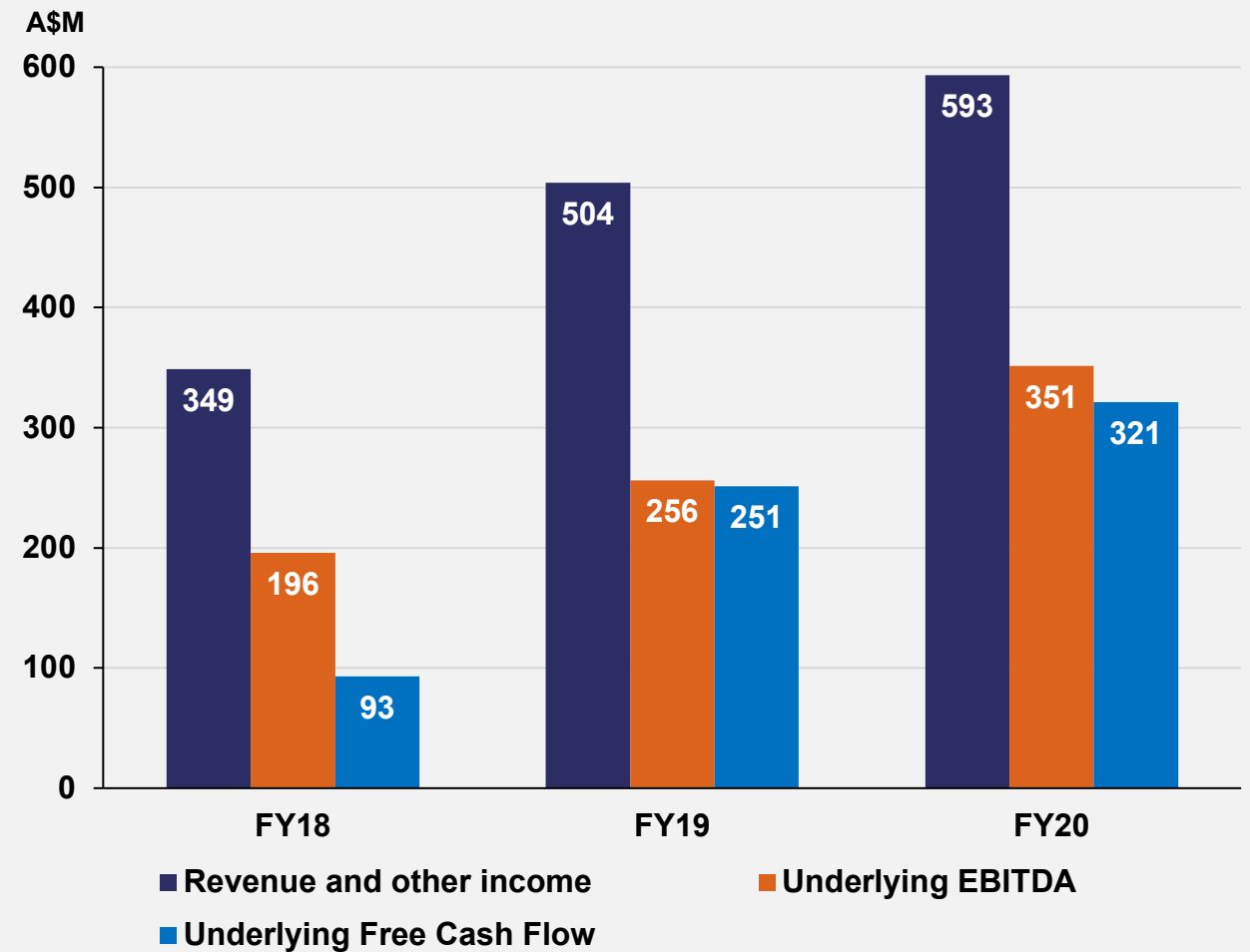

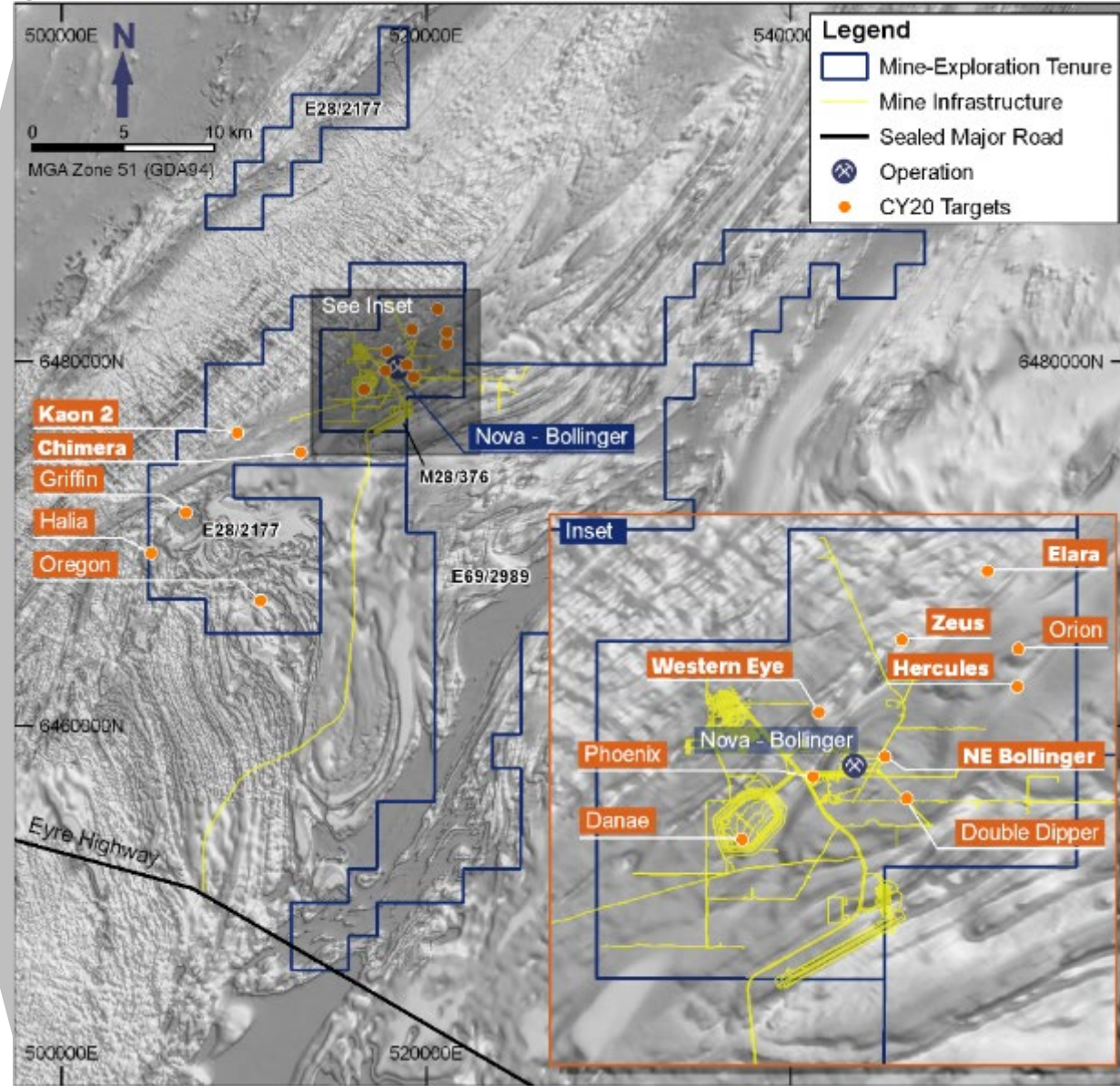

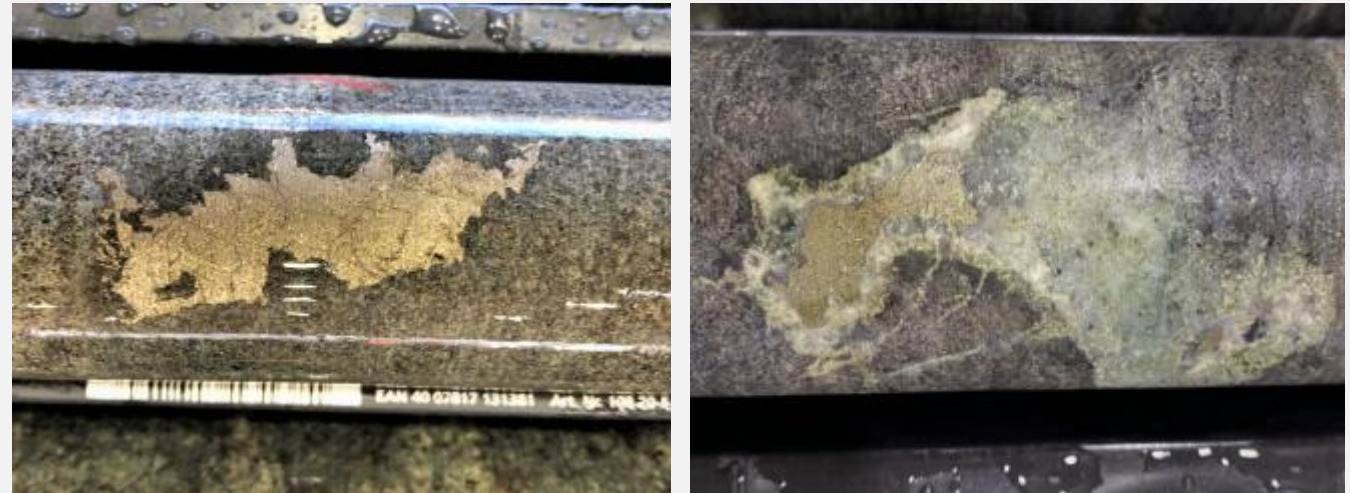

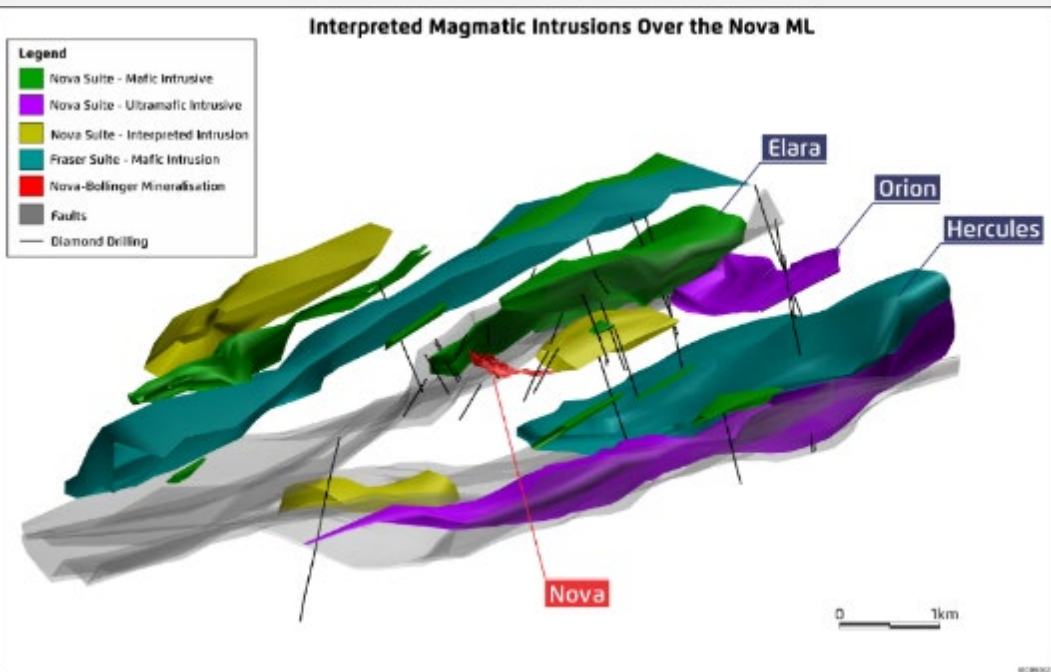

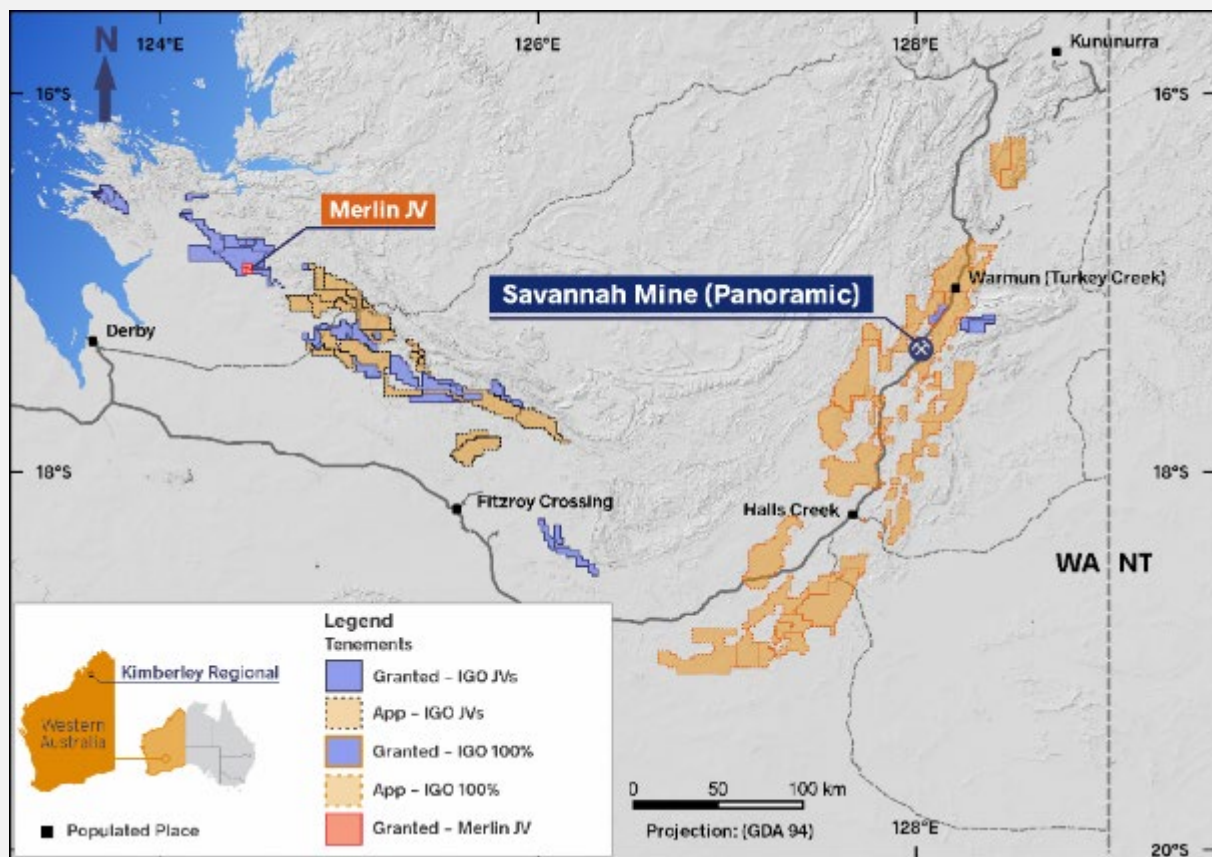
Pipeline of Nickel Opportunities

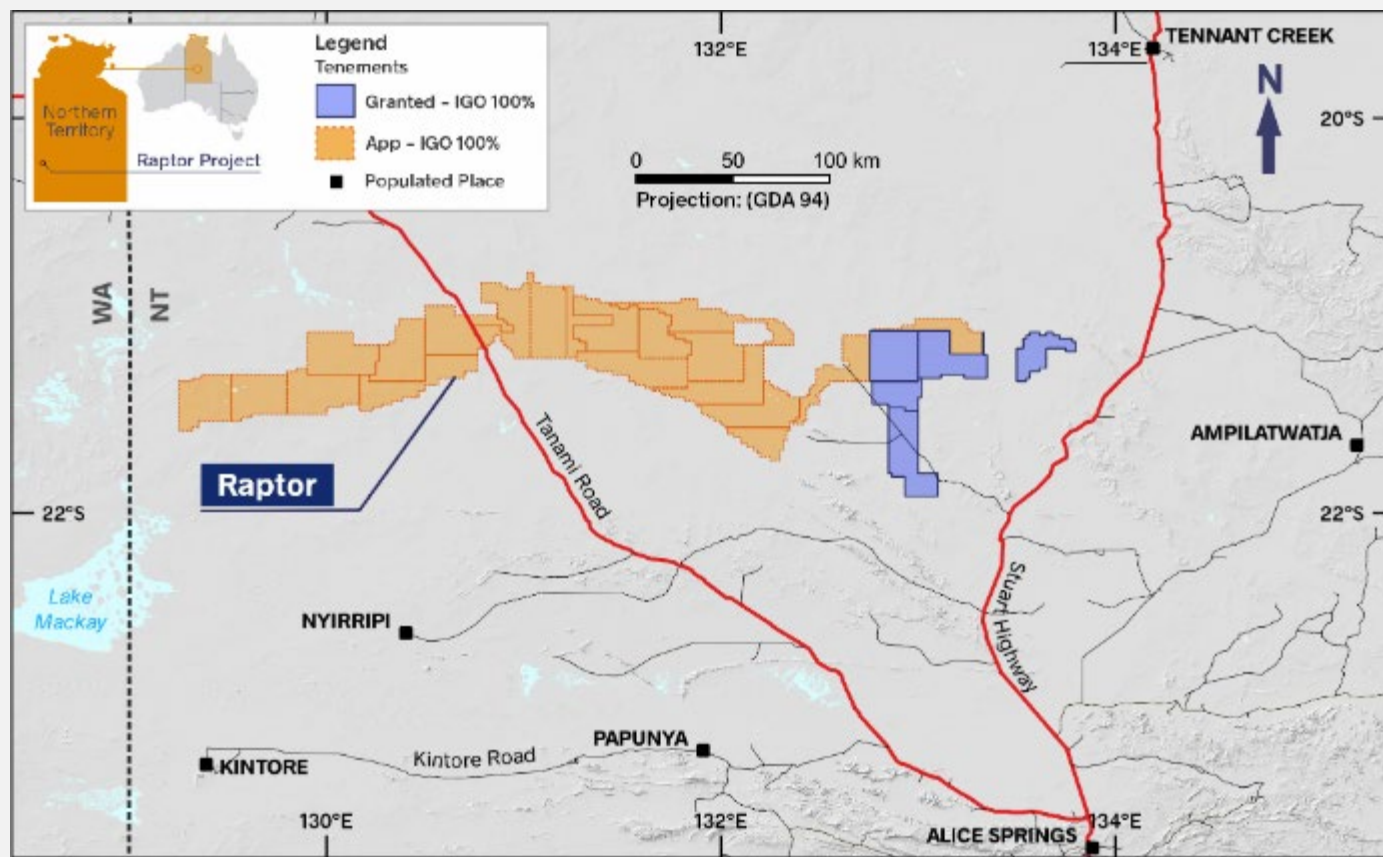

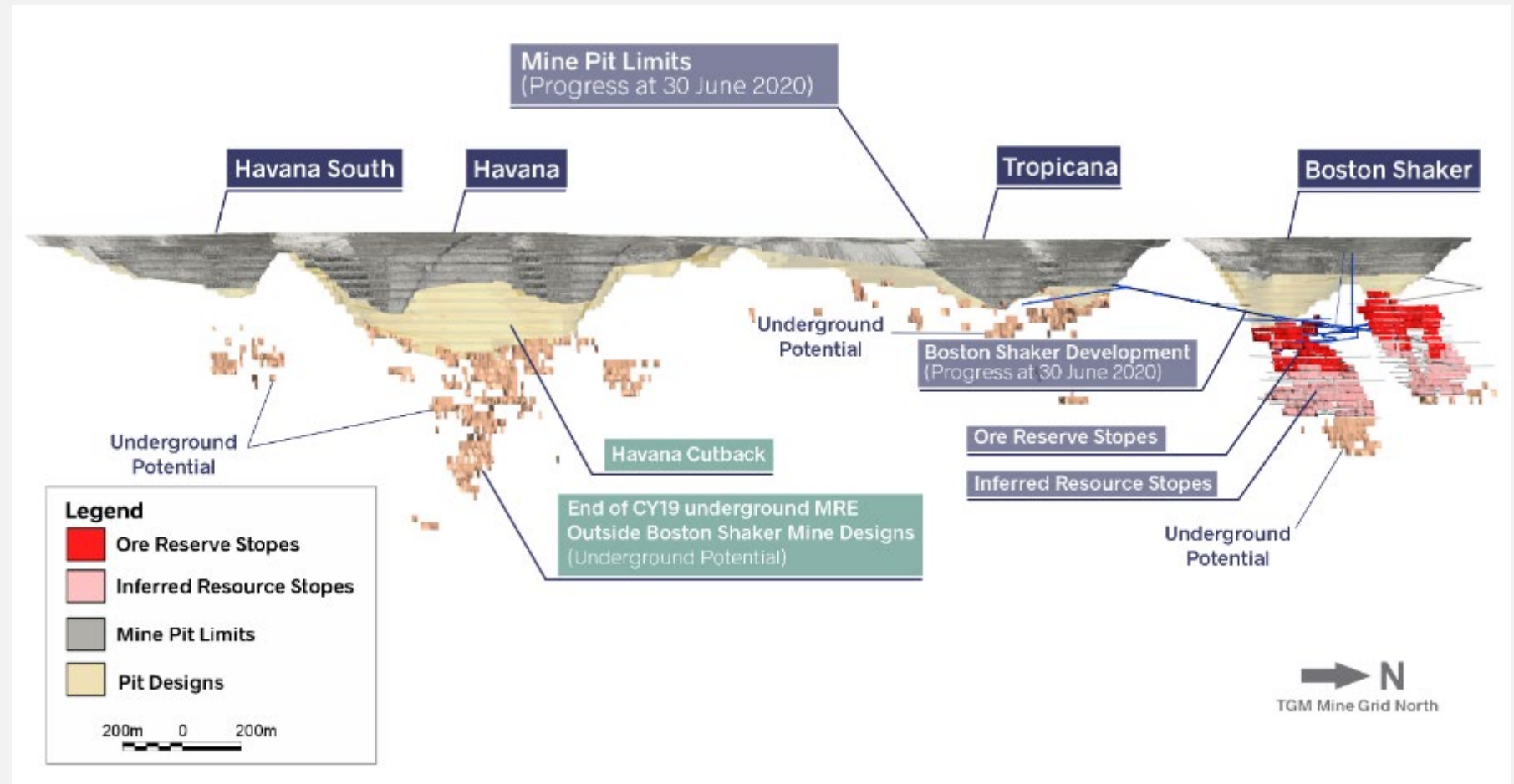
