(a) Where share price is greater than or equal to NTA Price

If the prevailing Share price is higher than or equal to the NTA Price, Participants will receive dividends as newly issued shares in the Company. In addition, the Company will promptly apply for quotation on the ASX of new shares issued and allotted under the Plan.

(b) Where share price is less than the NTA Price

If the prevailing share price is less than the NTA Price, dividends on shares subject to the Plan will be used to acquire Shares on-market. The Company has 20 trading days in which to do this on behalf of all Participants. The average share price, less brokerage and stamp duty, is then determined and the shares purchased under the Plan are allocated among the Participants in accordance with their level of participation. However, where the Company cannot buy enough shares on-market within 20 trading days to satisfy the full amount of dividends payable, the remainder of the dividend will be applied for the issue of new Shares or given to the Participant in cash as determined by the Board.
