### **Corporate Governance Statement**

This statement outlines the Corporate Governance practices adopted by the Board of Directors for the financial year ending 30 September 2021.

The Board of Aspermont Limited (**Aspermont** or the **Company**) is committed to conducting the Company's business in accordance with a high standard of corporate governance commensurate with its size, operations and the industry within which it participates.
