## **AUSTAL REACHES SETTLEMENT WITH ASIC**

Austal Limited (Austal) (ASX:ASB) has reached a settlement with the Australian Securities and Investments Commission (ASIC) in relation to ASIC's investigation into historical matters concerning the Company's market disclosures with respect to Austal's Littoral Combat Ship (LCS) program prior to 4 July 2016.

ASIC will apply to the Federal Court seeking a declaration of one contravention by Austal of the continuous disclosure provisions of the Corporations Act 2001 (Cth) for the period 16 June 2016 to 3 July 2016. Under the settlement, Austal will agree to the civil contravention and agree to seek a penalty of \$650,000.

Austal Chairman, John Rothwell welcomed the closure of ASIC's case.

"Austal takes it disclosure obligations very seriously," he said. "We have rigorous processes and procedures in place to ensure that those obligations are complied with at all times. Austal has cooperated with ASIC's investigation and reached agreement with ASIC on how its investigation should be resolved. We consider that this settlement is in the best interests of Austal as we continue to focus on our development of our shipbuilding business globally."

The matter is due to come before the Federal Court shortly for the Court's approval of the settlement.
