SPP Closes – Additional Funding to Support Commercialisation Strategy

Aurora Labs Limited (“A3D” or “the Company”) (ASX:A3D), is pleased to announce that its Share Purchase Plan (SPP) closed on 7 March 2023.

The Directors have agreed to accept eligible applications totalling \$499,500 in addition to the \$1.35 million received through the recent Placement.

Funds raised will be applied to implementing the ramping up the Company’s print services business, design and build of the Company’s go-to-market high power printer (known as the AL250), progressing technology development and testing of the Company’s proprietary and patented Multi-Layer Concurrent Printing (MCP™) technology, working capital and cost of the offer.

The Issue of Securities will occur on 14 March 2023.

As detailed in recent announcements ^{i,ii,iii}, the market release of the Company’s first commercial high power printer – the AL250, will target customers within energy, resources, defence and research sectors. A3D will also be delivering industrial print services across these sectors to grow revenue, including to customers such as Alcoa and Woodside, and build demand for the Company’s commercial printers. Concurrently the Company will continue to respond to interest from global manufacturers to jointly develop and advance the MCP™ technology.

Immediate activities include Design-for-Manufacture for AL250 to achieve local manufacturing at competitive pricing, required quality and reasonable supply timelines; and ramping up of marketing activities within the regional priority market sectors as a preferred entrée into machine supply.
