
AMOs and AMO Software Providers ITE activity continues to increase as progress is made with all business messages.


ITE Update

- The ITE environment has remained available and stable for Industry Testing throughout May
 - One ITE maintenance window on the evening of Thursday 1 May
- AMO test activity levels continuing to increase month on month
- Higher volumes of Trade Capture, Trade Cancellation, and Market Data Snapshot
- AMOs expecting to increase testing volumes when AMO Readiness release enables production volumes (from July)
- 4 new issues identified during AMO testing (targeting resolution in the AMO Readiness release):
 - CHR-18453: (AR) not generated when ASCII characters received in (AE) Tag 448
 - CHR-18662: (AR) populated with incorrect TransactTime (60) for Trade Cancellations
 - CHR-19318: FIX (W) rejected for missing MDEntryTime (273) Tag for repeating groups with MDEntryPx (270) = 0
 - CHR-19399: AMO sends a Logon (A) request with an invalid SenderComplD (49) and does not receive the appropriate messages to indicate the reason for the authentication failure.





03 - Clearing Regression Outstanding Questions and Actions



Approach to testing Deferred Settlements

- CHESS Project plans to test backwards compatible EIS 124 (Rescheduled Settlement Instruction) messages generated when a deferred settlement issue date is changed (including large volumes of open trades)
- CHESS Project proposes to validate expected EIS message flows for deferred settlement testing pre and post go-live
- Clearing Participants are to validate backward compatible EIS 128 messages are correctly received and processed by their systems.



Approach to using environment resets in ITE

- Approach to deployments including defect resolution in ITE is on a fix forward basis
- There are no plans to perform environment resets in ITE during the Clearing Regression phase
- ASX plan to communicate to Clearing Participants if an unforeseen event arises where an environment reset is required.



Approach to throttling AMO volumes

- To minimise the need to throttle and/or disconnect an AMO from ITE once their software is accredited, ASX Trade and Choe plan to introduce a filter which limits trades to specific securities for testing during Clearing Regression
- ASX intend to work with impacted AMOs to design Grouped Security List and publish in Clearing Regression Release Notes as planned.

AMO Trade Capture Reporting - Alternate File Ingestion Interface

- > Clearing Participants have requested Cboe and ASX Trade support integrated Clearing Regression testing by enabling their Customer

 Testing Environments with Release 1 software to report customer-initiated trades to the Release 1 Clearing Service
- Cboe and ASX Trade have confirmed they intend to:
 - Support integrated CP Clearing Regression testing once AMO Accreditation and Operational Readiness activities (Sep Early Nov)
 have been successfully completed
 - Perform several days of testing during Clearing Regression where AMO Customer Testing Environment trades are planned to be submitted to the Release 1 Clearing Service through the Alternate File Ingestion Interface (AFII)
- > Details of AMO Customer Test Environments supporting Clearing Regression test activity, including scheduling and AFII transmission, is planned to be published in the Release 1 Clearing Regression Release Notes.



Release 1 – AMO Readiness



AMO Readiness Release is targeting deployment on the weekend of 6 July to enable the remaining target state CHESS Release 1 capability. ASX intends to publish a schedule to support volume injections, failover, and Alternate File Ingestion.

- Alternate File Ingestion Interface (AFII)
- > Business continuity tool to upload FIX format files to the Release 1 Clearing Service via SFTP
- > When enabled, AFII can regularly process intraday files containing AMO Trade Capture and Market Data Snapshot records
- SFTP and file specifications outlined in the AMO User Technical Documentation

- Securities Details
 FIX Message
 - Reporting message to notify AMOs of security details held in CHESS
 - > Optionally enabled at COMP-ID level – recommend AMOs enable one COMP-ID where multiple exist
 - Report data is static until AMO Operational Readiness phase
 - Message specifications outlined in the AMO User Technical Documentation

 Endpoint
- Optional endpoint for AMOs to manually connect to if primary endpoint unavailable




Release 1 – Parallel Test Update






Appendix A – CHESS Release 1 Indicative Project Timeline – June 2025
