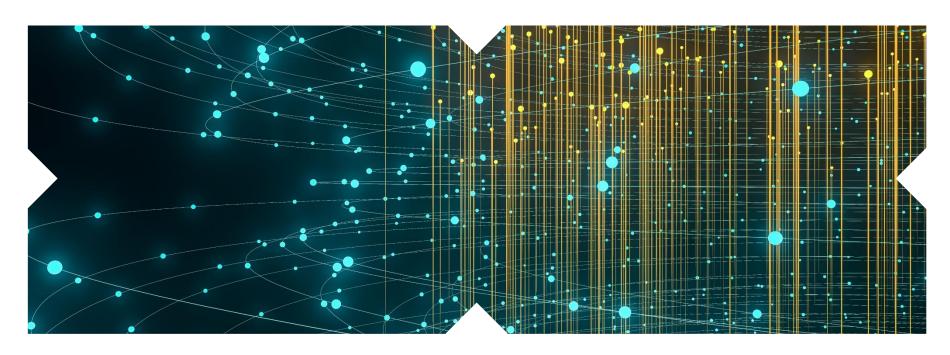

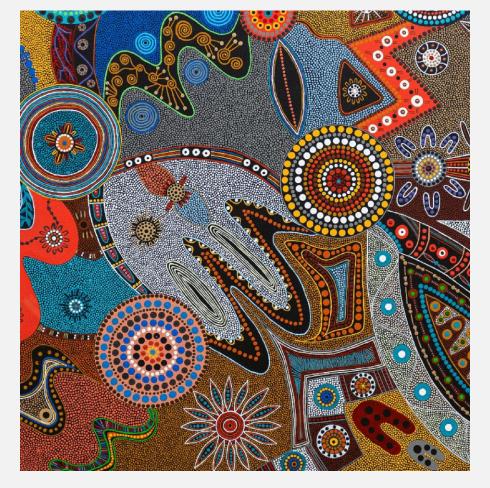

- > Acceptance: SRN(s), registration details and holding balance
- > Rejection: reason for rejection

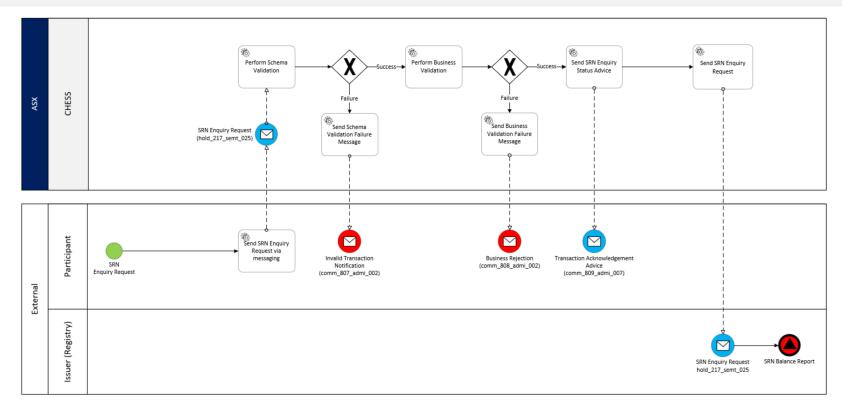

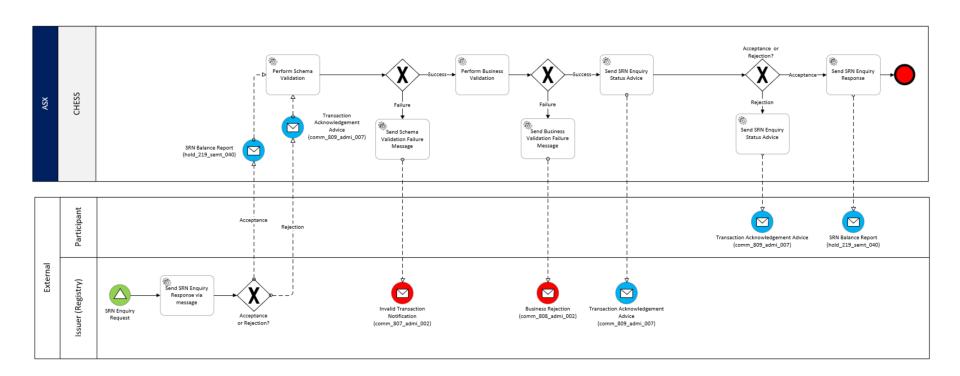


#### SRN Enquiry Request - Process Flow





#### SRN Balance Report - Process Flow



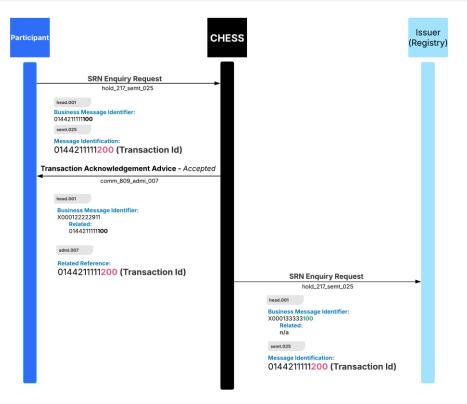


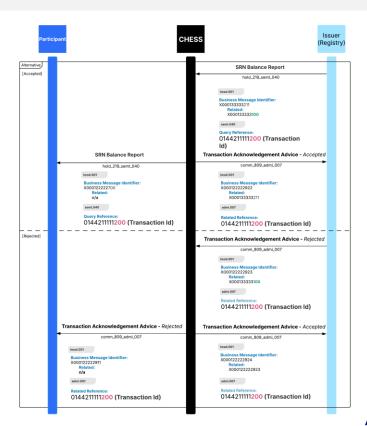

### 03 – Transfers & Conversions

#### Overview

Holdings can be transferred or converted between the different subregisters in CHESS

- > Holdings maintained on the CHESS subregister are identified using a HIN (Holder Identification Number)
- > Holdings maintained on the Issuer Sponsored subregister are identified using an SRN (Securityholder Reference Number)

#### **Transfers**

- > Registered holder(s) on the source and target accounts (HIN/SRN) may be different
- > CHESS to Issuer Sponsored
  - Source account (HIN) and target registration details must be provided
  - Participant may request for the SRN be notified after the successful transfer
- Issuer Sponsored to CHESS
  - Source account (SRN) and registration details (optional) as well as the target account (HIN) must be provided
  - Settlement only participants can complete a pre-transfer check and provide the source account (SRN) registration details rather than a signed registerable transfer document
  - Issuer (Registry) is required to accept or reject the transfer request

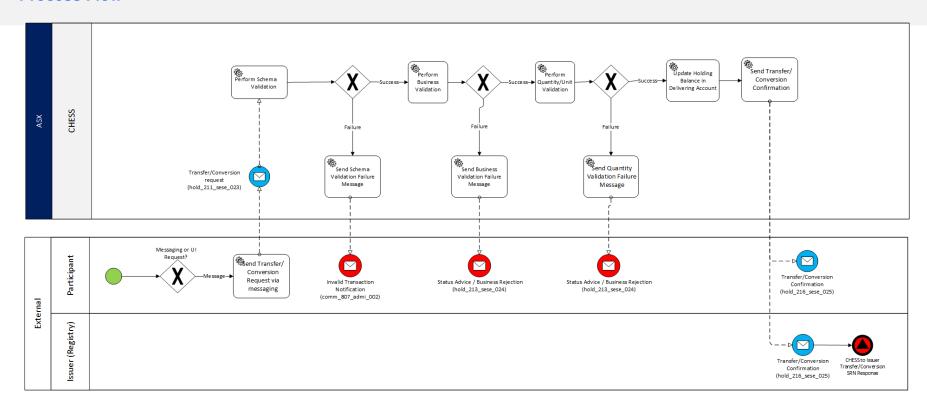

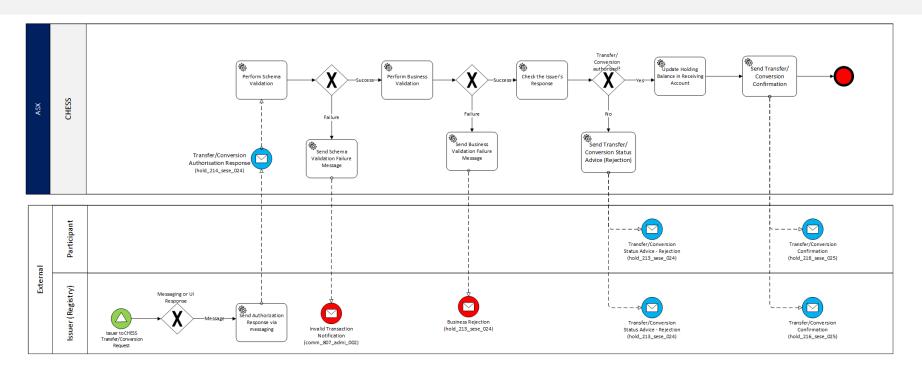


#### **Request Process Flow**



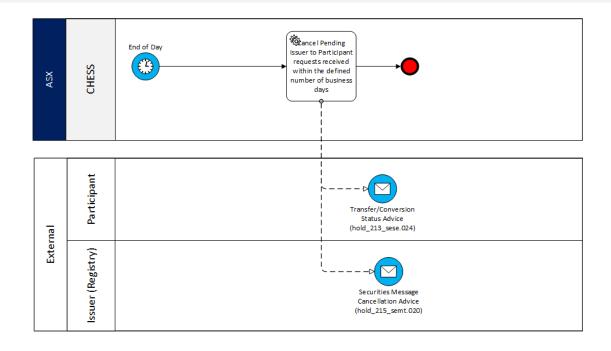


#### **Response Process Flow**
