

02a – Updated Release 1 Indicative Project Timeline – March 2025



02a – Project Status

> ITE Open

- The Project is targeting to launch the Release 1 Industry Test Environment (ITE) for commencement of the AMO Build and Test phase on 28 February 2025. Key members of the Project approved external access to the ITE on 19 February 2025
- Testing for AMO build and test functionality is complete
 - There were no critical severity defects
 - 3 high severity defects were risk accepted with work arounds in place of which only 1 impacted AMOs

> Drop 3

- Drop 3 was delivered on 31 January 2025 with testing commencing on 18 February 2025
 - Drop 3 includes integration to the ASX identity system and reference data system
- The Project is currently tracking amber due to the testing scope carried over from Drop 2, increasing delivery schedule pressures for the AMO Readiness phase
 - The Project plans to mitigate potential impacts to the testing schedule by retaining existing resourcing and have key SMEs available from BaNCS in Sydney to support the testing

Data and Reporting

- Baselining of the workstreams that support critical path integrations or external reporting was completed mid-February 2025.
 Additional resources are required to meet the revised timelines
- The remaining workstreams support ASX's internal reporting and are planned to be baselined by late-February 2025.


- Other Release 1 Updates
 - ASX's Drop 4 build has commenced and is targeting delivery by the end of March 2025
 - Drop 4 delivers internal facing features including parallel test tools to support parallel testing and CHESS User regression build and support, FIX message enquiries and test tools for regression build and support
 - Major incident testing is scheduled to commence scoping and planning in March 2025
 - This involves assessing system resilience, validating recovery processes, and ensuring the support model can
 effectively manage incidents
 - This is a key phase to demonstrate both technical and operational readiness across support teams, ensuring they are prepared to handle incidents in the lead-up to go-live.

02b – Project Status

Release 2 is tracking to plan with a number of additional resources onboarded to support delivery of Drop 1 and Drop 2

- > Drop 1 and 2
 - Drafting of the business requirements for Drop 1 is tracking to plan with the Project targeting sign-off by late-April 2025
 - Build for Drop 1 feature scope is scheduled to commence from June 2025
 - Pre-analysis for Drop 2 is targeted for completion by late-April 2025
- > Other Release 2 Updates
 - Engagement on optional or mandatory nature of new functionality commenced with industry feedback requested by 12 March 2025. Refer to slide 41 for overview of current industry feedback.







04b - Release 1 Clearing Regression Overview

In preparation for the Clearing Regression phase, ASX proposes to capture early feedback to develop the guide that is targeted to be published next quarter

Clearing Regression Phase

Between October 2025 and February 2026, Clearing Participants are required to perform internal testing and validation of all downstream EIS messages received that result from trade registration, clearing and netting services. This is a mandatory industry test phase where Clearing Participants and AMOs will be operating in the same test environment.

04b - Learnings From Previous Project PIR

PIR feedback highlighted the approach to tooling in the last project generally met industry needs, however various areas of improvement should be considered



- End user testing Test environment and data should be closer-to-production quality
- Should have the ability for CHESS Users to test processes independently (prior to IWT)
- Solutions should enable user testing to be as automated as possible
- Solutions should allow multiparty workflows without the need for assistance (e.g. test transfer HIN to/from another Participant)
- Use cases should consider "day in the life" for each user group
- Provide clearer status on test environments
 e.g. known issues, environment status, & active corporate actions event calendar



- Continue with Turn Around PID auto initiators / responders
- Continue with solutions to load / request test scenarios or additional data (templates could be improved overall – seemed unnecessarily complicated)
- Supportive of the CHESS UI approach as a tool to support self service testing of multiparty workflows



Data

- Corporate action events should flow from production to improve test quality
- Require more (synthetic) corporate actions running to get good coverage for testing (lack of events to test against & do not want to wait a month between cycles to retest)
- More takeover events are required
- Securities with concurrent corporate action events should be created



- > ASX acknowledges cost and impacts of such functionality to the Registries, and plans to meet with Registries to:
 - Jointly explore and define a beneficial approach for developing Corporate Action functionality
 - Understand the Registries business objectives and challenges, enabling (where reasonable) ASX to align the Corporate Action functionality development with their strategic goals to ensure it meets their specific requirements
 - Ensuring the development of Corporate Action functionality supports both immediate and long-term business needs
- > ASX aims to provide the Technical Committee with a proposal before seeking Business Committee endorsement (prior to commencing detailed design in BDWGs).


