

AMO Readiness Preparation

- Testing has progressed and is expected to be completed by late-June 2025
 - AMO Security Details Report build has been completed and testing is targeted for completion by late-May 2025
 - Reference data testing is progressing in the end-to-end environment
 - Identity integration testing is progressing and targeted to be completed by mid-May 2025
- BaNCs performance testing on 20 million trade messages per day was completed in late-April 2025. This was the final scenario to complete performance testing for BaNCS led NFT
 - ASX performance testing in the NFT environment commenced late-April 2025.

Clearing Regression Preparation

- Detailed planning for the clearing regression phase has completed to align on detailed requirements, data and environments
- Build commenced on clearing regression tool which will convert trades to FIX messages.

Other Release 1 Updates


- Technical dress rehearsals (TDR) planning is in progress with the 1st internal TDR planned for July. Discussions underway with AMOs to understand their cutover plan
- Data and reporting 3 of 4 open roles have been fulfilled and velocity in the stream has improved significantly.

Drop 1

- Drop 1 business requirement documents have been drafted have been signed off on 30 April 2025. Specification documentation is in progress and BaNCS build is scheduled to commence in mid June
- Design of the external user interface has been completed and design of the new channel for ISO messaging is targeted to be complete mid-May 2025.

Drop 2 and 3

- Initial design and discover work (pre-analysis) for Drop 2 is targeted for completion by 30 April 2025
- The drafting of Drop 2 business requirements and pre-analysis for Drop 3 will commence from early-May 2025 onwards.

Release 2 Testing

CHESS Release 2 Joint Test approach and test resource onboarding is in progress.


- > The ITE environment has remained available and stable for Industry Testing throughout April

 - CHR 15238: FIX (W) Message requires decimal value in MDEntryPx.








03 – ITE message activity since ITE open

An Implementation & Transition Working Group was held on 29 April with a focus on CHESS Release 1 industry test phases and cutover

 - Noted data variances in generation of Transaction ID, Origin Transaction ID and Updating Transaction ID field length remains unchanged
 - Discussed options to load test data
 - Clearing Participant File Upload
 - AMO Integration via FIX Gateway (subject to AMO availability and conditions)
 - Introduced Clearing Regression Test Kits and XPI support.
- > AMO Operational Readiness
 - Provided an overview of the upcoming AMO Operational Readiness Phase.
- Cutover and Transition
 - Viewed an indicative timeline for Release 1 Cutover & Transition
 - Discussed the planning of Industry Dress Rehearsals and Parallel Test dates.

04c – Business Design Working Group – Release 2 Drop 2 Deep Dive (#1)

A Business Design Working Group session was held on 3 April to deep dive on areas of change in relation to clearing and settlement

Clearing

- ASX presented a revised proposal for trade acceptance and netting that builds upon the work done in February 2024, adjusted with a view to minimising changes for T+1
- ASX presented a recap on position accounts and how they can be used to segregate clearing and settlement flow
- Participants provided feedback in relation to processing crossings and potential for future functionality such as give-up/take-up
 and clearing-only participants.

Settlement Instructions

- ASX presented walkthroughs of the fields available in BaNCS and proposed matching criteria
- Participants provided feedback on field usage and matching criteria. Feedback will be consolidated and a revised proposal will be presented at the May BDWG.
- > May BDWG Release 2 Drop 2 Deep Dive (#2)
 - Due to issues with timing further discussions on matching tolerances and finalisation of the proposal for Foreign Restricted securities was deferred to the May BDWG
 - Settlement processes will be presented as well as a revised proposal for matching fields based on participant feedback
 - Additionally further feedback in relation to TFN & Bank Account is planned to be discussed.

CHESS Release 2 Operating Rules



- > The legal arrangements are being amended to reflect the CHESS Project system technical build
- Aim to minimise changes to existing Rules and Procedures
- Plan is to consult on all Rule Changes relevant to Release 2 in a single consultation process in line with the Release 1 Rules and Procedures consultation but will work in parallel with the Release 2 roadmap to develop the rule changes as each drop is finalised. Noting: the previous iteration of the CHESS Project consulted in three tranches
- > Consultation will use material consulted on in previous iteration of the CHESS Project, where relevant and appropriate
- > ASX is planning for the Release 2 Rules consultation to commence some time in Q2 2027 for a period of 3 months (typically 6 weeks is standard). ASX is continuing to refine the Release 2 rules timeline and plans to provide an update later in Q2 2025
- Any members that wish to receive a copy of the Subscriber Technical Access Agreement (STAA) should request one.

 ASX anticipates the Release 2 STAA will be in a similar form to the standard STAA, subject to any necessary amendments
- ASX is planning for the relationship between the legal (Rules, UTD) and business (APGs) documents to remain the same as it is in existing CHESS.
