

02a – CHESS Release 1 Project Status

AMO Readiness Preparation

- The AMO Readiness phase is expected to commence on 7 July 2025 as planned
 - Functional testing on key AMO Readiness scope and non-functional testing has been completed
 - The implementation readiness assessment for deployment has been signed off
 - The AMO Readiness Release Notes and User Technical Documentation were published on 2 July 2025
- 6 known issues and the work arounds have been listed in the Known Issues Log
 - 4 relate to negative test scenarios, 1 is an existing known issue and 1 requires input from the AMOs
 - These are expected to be discussed with AMOs and their Software Providers at the 17 July CHESS Release 1 Build & Test Forum
- The alternate file ingestion interface to enable failover testing and fixes to the known issues are expected to be delivered via a patch release targeted for late-July 2025.

Clearing Regression Preparation

- Enhancements to the alternate file ingestion interface to support Clearing Participant trade upload is in progress. These enhancements will convert trades provided by Clearing Participants and convert these into FIX messages
- The Clearing Regression Guide was published on 25 June 2025 as planned.

Other Release 1 Updates


- Preparation for the CHESS Release 1 cutover is progressing, and the CHESS Project Release 1 Cutover Approach was published on 26 June 2025
- Technical dress rehearsals are expected to commence in July 2025. This will be followed by 2 ASX Dress Rehearsals expected in August 2025 and September 2025. Implementation Dress Rehearsals with the AMOs are planned for November 2025 and February 2026
- Build for parallel test tooling is in progress and to be used for ASX internal parallel testing activities which are expected to commence from late-July 2025
- Operational acceptance testing has commenced the purpose of OAT is to assess the technology support team's readiness and the operational effectiveness of controls by identifying and mitigating any operational risks prior to go-live.

02b – CHESS Release 2 Project Status

Drop 1

- Functional business specification documentation have been signed-off and BaNCS build has commenced as planned. BaNCS build is targeted to be completed by late-September 2025
- Build for the AMQP and external UI channels is in progress and expected to be completed by late-September 2025
- Initial deployment of the BaNCS CHESS Release 2 vanilla settlement application is currently in progress
- Drafting of the CHESS User Technical Documentation for Drop 1 is currently in progress and targeted for publication in late-August 2025.

Drop 2 and 3

Drafting of the Drop 2 business requirements and pre-analysis for Drop 3 is expected to be completed by late-July 2025.

Industry Test Preparation

- The Release 2 Industry Test Approach drafting is in progress, targeting to be published late September 2025. This document will summarise all phases in plan for Release 2 Industry Testing, including further details related to the Industry Test Environments, test tools and data, tracking progress and the support model in place
- Industry Timeline checkpoints will also be explained further in the Release 2 Industry Test Approach
- Release 2 Industry Test Approach content including Industry Timeline checkpoints will be discussed in upcoming I&T WGs.

03 – ITE Activity in June

AMOs and AMO Software Providers successfully transmitted all remaining messages for all available accreditation scenarios in June 2025

and are awaiting the AMO Readiness release to complete remaining build.

ITE Update

- The ITE environment remained available and stable for Industry Testing throughout June
- AMO test activity levels decreased slightly on May volumes as AMOs completed build for available functionality
 - Available scenarios have been successfully completed by all organisations
 - Message rejection volumes significantly decreased as software build progressed
- AMOs are expected to increase testing volumes again when AMO Readiness release enables production level volumes
- One new issue identified during AMO testing which is currently under investigation
 - Resolution of issues raised in previous months awaiting deployment in the AMO Readiness release.








03 – ITE Message Activity since ITE Open

04a - Implementation & Transition Working Group Update

An Implementation & Transition Working Group was held on 26 June focussing on CHESS Release 1 AMO Readiness, Clearing Regression and Parallel Testing

- > AMO Readiness
 - Discussed the targeted deployment of AMO Readiness codebase and availability of the Industry Test Environment in early-July 2025
 - Reviewed the proposed schedule of AMO non-functional and ASX assisted testing activities to support:
 - Production and stressed volumes
 - FIX Gateway disconnections and failovers
 - Alternate file ingestion interface for BCP events.
- Clearing Regression
 - Presented an overview of the Clearing Regression Test Guide
 - Discussed the proposed approach for testing deferred settlements
 - Some AMOs have confirmed their intentions to support Clearing Regression for Clearing Participants planning to perform integrated testing.
- Parallel Testing
 - Presented a proposal for Clearing Participants to obtain test EIS data generated during the AMO Parallel Test phase.

Pricing considerations for the CHESS Project



06 – Pricing considerations for the CHESS Project

Feedback has been received that functional changes made as part of the CHESS Project may impact fees charged under the current fee model

- > ASX has implemented a new Cash Equities Clearing, Settlement and Issuer Services Pricing Policy ('Pricing Policy'), effective 1 July 2025
- As part of the work on Release 2 of the CHESS Project, there will be a body of work to map the functionality in the new system to the existing functionality in the current system from a billing messaging perspective. Any new optional services will also be mapped and priced with reference to the new Pricing Policy
- ASX will then consult on this mapping exercise for market feedback. ASX anticipates that this work will commence in 2027, in preparation for the 2029 go-live of Release 2.
