## The ASX Commodities product suite

### Electricity (AU and NZ)

- Electricity Futures and Options covering Australia and New Zealand
- Futures listed over base and peak demand periods
- Trade monthly and quarterly futures, caps and strips

### Environmental (AU and NZ)

- Australian and New Zealand carbon and renewables markets
- Physically delivered
- Provides a transparent forward curve out to 5 years

### Australian Natural Gas

- Regional Gas Futures covering Australian east coast gas markets
- Physically delivered and cash settled contracts
- Provides a transparent forward curve out to 3 years

### Australian Grains

- Futures and Options over Eastern Australia Wheat and Feed Barley
- Physically delivered via key grain hubs
- Provide cost effective exposure to an alternative asset class

## Why use ASX Commodity derivatives



### A transitional energy ecosystem

ASX derivatives support forward trading in energy, gas, carbon and renewables markets.



### Price discovery

Futures can help improve price and data transparency by creating liquid forward curves that are readily tradable.



### Pooled liquidity

Offering standardised, centrally cleared instruments traded on an anonymised basis in liquid and diverse markets.



### Risk management

Protect against price fluctuations and take greater control of the prices you pay or receive.



### Unique alpha

Commodity derivatives can be uncorrelated to other financial markets and asset classes creating unique opportunities to diversify and generate returns.



### Centralised clearing

Trade on centrally cleared markets. With the Clearing House becoming the buyer to each seller and the seller to each buyer, counterparty risk is reduced.

- Covers trading in the National Electricity Market (NEM) which supplies 80% of Australia's electricity needs
- Access a range of derivative contracts including caps, strips and options
- Uncorrelated to other asset classes offering unique alpha opportunities



### Carbon and Renewables

Trade Australian and New Zealand carbon and renewables markets using ACCU, LGC and NZU Futures

#### Key features

- Listed out to 5 years
- Physically delivered into the relevant registries for compliance surrender
- Standardised terms
- Transparent forward curve
- Reduced credit risk through anonymised trading and central clearing



### Natural Gas

Gas plays an important role in stabilising energy supply as Australia transitions to net zero

#### Key features

- Futures listed over Australian east coast wholesale gas markets
- Wallumbilla Gas Futures are physically delivered via the Gas Supply Hub
- Transparent forward curve out to 3 years
