

# ASX Grain Futures: Lodgement of Grain

This guide is for ASX Clear (Futures) Clearing Participants.

The customer will transfer the grain to the ASX Clear (Futures) account at the Approved Bulk Handler using the electronic transfer capability.

Each Title Transfer must contain the Participant mnemonic and Client account number on the transfer.

Each lodgement of grain must contain the equivalent of 20 tonnes shrunk or a multiple of 20 tonnes shrunk and meet the contract specifications for:

- Commodity
- Grade
- Season
- Tonnage
- Location

Unidentified or incorrect Transfers will be rejected to the party submitting the Transfer at the Approved Bulk Handler.

Once ASXCF receive advice from the Approved Bulk Handler that grain has been lodged in the ASX Clear (Futures) Pty Ltd account, the grain will be lodged in the Participant's name within ASX systems within the following timeframes:

Deposit by 2pm: Same day  
Deposit after 2pm: Following Business day

On lodgement, the Participant will be able to view their lodgement and associated ageing on the **Depository Holdings Activity Listing Report**.

At the completion of the 2 day ageing period, the lodgement will appear on the **Depository Holdings Listing Report** for the time of lodgement with ASX Clear (Futures).

A pdf report and xml file for both the Depository Holdings Activity Listing report and the Depository Holdings Listing report will be distributed via NOMX Secure at:

During Delivery period month:  
 Intraday 10am, 11am, 12pm, 1pm, 2pm and 3pm; and  
 End of Day
